The Vice-Chancellor of Jamia Hamdard through a Notification of even No. 03, dated 3<sup>rd</sup> January, 2024 has appointed Prof. Khaja Naseeruddin, Head, Department of ENT, HIMSR as the new Dean/Principal, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard in exercise of his powers conferred under Clause 23-I of the UGC (Institutions Deemed to be Universities) Regulations,2023 and he assumed the charge of the Dean, HIMSR on the same date. http://www.jamiahamdard.ac.in/PDF/Office%20Order/Reg%20appointment%20of% 20Prof.%20Khaja%20Naseeruddin%20as%20Dean,%20HIMSR.pdf

- 2. Prof. Naseeruddin has accordingly joined his duties and has been performing his statutory duties as Dean/Principal, of the HIMSR, Jamia Hamdard. Subsequently, the said notification was challenged before the Hon'ble High Court through O.M.P. (I) 1/2024 titled Asad Mueed & Another Vs Hammad Ahmed, Jamia Hamdard & others which was listed before the single judge Justice Anup Jairam Bhambani, Hon'ble High Court of Delhi on 10.1.2024. The Hon'ble High Court did not give any relief to Mr. Asad Mueed and disposed of the said petition through a detailed order dt. 10.1.2024. It is candid clear from the said order that the Jamia Hamdard is not a party before the Arbitration proceedings.
- 3. You are, hereby directed to vacate the chamber of the Dean, HIMSR, Jamia Hamdard immediately as on the appointment of new Dean, HIMSR, you are supposed to report back to your department i.e. Department of Microbiology, HIMSR.
- 4. Through this letter, It is also made clear to you that as per University Bylaws and the UGC (Institutions Deemed to be Universities) Regulations as amended by time to time as well as the NMC Regulations, the power to appoint the Dean/Principal or any other key personnel in its institutions including the Hamdard Institute of Medical Sciences & Research which has been established by the Jamia Hamdard, vests with the University authorities and the Vice-Chancellor and not with any third party including its sponsoring body or funding bodies.
- 5. The University has already adopted the provisions of the UGC (Institutions Deemed to be Universities) Regulations, 2023 as adopted by the University through Notification dated 11<sup>th</sup> Sept 2023 and a copy of the same has been made available

the on University website for information all concerned. http://www.jamiahamdard.ac.in/PDF/Notification%20reg.%20adoption%20of%20UG C%20Regulations%202023%20by%20Jamia%20Hamdard.pdf. You may please note that according to the new UGC Regulations, 2023, there is no provisions of grant of status of constituent institution and allow the sponsoring body or funding body to interfere with the day-to-day functioning of the any academic unit or school or institution of the University facilities like HAH Centenary hospitals. These UGC Regulations were notified by the UGC with the previous approval of the Central Government has already come into force from the date of their publication in the Official Gazette i.e. 2<sup>nd</sup> June, 2023 without any exception.

6. Further, the University will not validate any official papers signed by you as Dean, HIMSR whatsoever on or after 3<sup>rd</sup> January, 2024. A copy of this letter is being sent to the Secretary, National Medical Commission, New Delhi is also being informed through this letter.
