The Vice Chancellor welcomed all the Members to the first meeting of the newly constituted Committee. He expressed hope that since in the Committee there is diversity in terms of fields expertise of members, Jamia Hamdard will be benefitted with their rich experience. He highlighted importance of IQAC in raising and sustaining quality standards at all levels of the University functioning. He also emphasized on the importance of participation of all stakeholders in quality activities.

Dr. B.P. Sanjay lauded role of Jamia Hamdard especially in the field of education in Pharmacy and stated that under the dynamic leadership of Dr. G.N. Qazi University shall progress leaps and bounds. Mr. Siraj Qureshi also recalled his long association with Jamia hamdard and hoped that Jamia Hamdard has a bright future. He however, pointed out that there is need to enhance visibility of the University and scope of improvement in presentation to public. Dr. Samathaman appreciated the contribution of Jamia Hamdard in research and hoped that current leadership will continue that mission.

2. PERUSAL OF NAAC PEER TEAM VISIT REPORT AND ITS RECOMMENDATIONS ACTION PLAN FOR THE SAME

The report and recommendation of NAAC peer team which visited Jamia Hamdard on 20-22 October 2010 was shared with the members and a presentation was made by the Director, IQAC on the same.

After detailed deliberations the following was resolved.

- Strengthening of Departments of Management and Department of Chemistry in terms of faculty and infrastructure will be taken on the priority basis.
- Automation of library services and overall improvement in library infrastructure will be taken up.
- Allocation of budget for research activities to be increased and some scheme of incentive for high quality research by faculty and scholars.
- Facilities at Central Instrumentation Facilities will be strengthened.
- Departments will be encouraged to undertaken collaborative research.
- Departments shall be encouraged to submit UGC-SAP proposals for major funding.

- Upgrdation of sports facilities and Gymnasium to be undertaken with appropriate budget provisions.
- 3. PRESENTATION BY DIRECTOR, IQAC ON VARIOUS QUALITY INITIATIVES AND QUALITY ASSURANCE REPORTS

Director, IQAC made a presentation on quality report of the University. Members appreciated these efforts and recommended that IQAC may be provided adequate administrative and financial support.

In this regard the Vice Chancellor informed that appropriated space has been allocated to IQAC and other support (manpower, budget) shall also be offered to make IQAC a viable centre.

4. PERUSAL OF FEEDBACK FORMS DEVELOPED BY THE IQAC

Director, IQAC shared the draft of Feedback forms. It was resolved that it will shared with all the teachers, Heads o the Department and Deans of Faculty for their suggestions. Heads of the Department will be advised to involve students also in this exercise.

Members appreciated and approved quality initiatives of the University with regard to recruitment and promotion of teachers on quality parameters which are some level above the UGC prescribed minimum standards. Members also appreciated efforts of the University in raising quality of Ph.D. ptogramme.

Section IV: Recommendations for quality Enhancement of the University

- Introduction of choice based credit system with credit transfer facility to facilitate horizontal mobility of students with vertical integration of knowledge.
- Establishment of exclusive University-Industry interaction centre as a statutory body with wholistic consultancy norms with administrative and financial autonomy.
- Modernization of both central and departmental libraries with functional IT connectivity coupled with skill building to maximize the library usage by students.
- Rejuvenation of the departments of Chemistry and Management with teaching programmes of modern needs and starting of new courses like Multimedia, Clinical Psychology, Human Genetics, applied statistics, besides rationalization of management department into a business school.
- Introduction of exclusive budget head for 'Research' by the University to provide for research starter grant, University research fellowships and to augment research equipment infrastructure for PG and Ph.D. students.
- To facilitate more number of departments to become eligible for UGC-SAP status and for Centres of Excellence by National and International funding agencies.
- Cross subsidized, skill based and employment oriented UG and PG programme for socially and economically weaker sections may be expanded.
- University level sophisticated instrumentation centre with high-end equipments and trained personnel to work in 24x7 time schedule catering to all the departments of the University.
- Augmentation of sports and cultural activities by engaging expert personnel.
- Establishment of University level Placement Cell and a provision for personal counselling of the students.

It is submitted here that in a meeting of IQAC Committee held on 27/01/2012, it was resolved that the suggestions of the NAAC peer team may be followed so that the deficiencies as pointed out may be rectified and the quality standards may be achieved as per the NAAC indicators.

In this regard necessary action taking directives may be issued to the concerne departments/sections.

Regarding recommendations for research activities the following is proposed for approval.

- 1. The departments may be encouraged to submit interdepartmental research proposa where at least one Principal Investigator is involved from other department/facul (Action: All Deans and Heads of the Departments)
- 2. While budget allocation is being made for each department which has established itself as a research department besides teaching activities, a separate allocation management be made under the head 'Research'. The allocation made for research equipmer and a portion (about 25%) of chemicals and consumables grant may be earmarke under the 'Research' budget head. (Action: Finance Officer)
- A proposal regarding centralised Instrumentation Centre has already been submitted Deans of faculty of Pharmacy and Science and further action is awaited. (Actic Deans, Faculty of Pharmacy and Science and Advisor (Research).
