CIRCULAR

7. BBA and Hotel Management Programmes under SMBS (6th Semester only)
8. Paramedical Programmes under SNS&AH (6th and 8th Semesters only)
9. B.Sc. (Nursing) Programme under SNS&AH (2nd and 3rd Years only)
10. B. Pharm Programme under SPER (6th and 8th Semester only)
11. B. A. L.L.B. Programme under HILSR (6th and 8th Semesters only)
12. B. A. Media and Mass Communication Programme under CMMS (4th Semester only).

Examination already announced and being held, if any, will continue as per schedule in the same mode.

All the students of above Academic Programmes and Semesters/ Years are hereby directed to report to their respective department(s), accordingly.

The respective HoDs and Dean are also advised to make necessary arrangements for offline classes accordingly.
