ADMISSION NOTIFICATION: JUDICIAL SERVICES COACHING

The Jamia Hamdard Residential Coaching Academy (JHRCA) besides the Civil Services Coaching concurrently also runs the Judicial Services Coaching Programme of 20 months duration in offline mode through regular classes.

This coaching is exclusively for the candidates hailing from the Minority communities, Scheduled Castes, Scheduled Tribes and Women.

It shall be mainly focused towards the Delhi Judicial Services Examination and shall essentially touch upon the core components of the Judicial Services Examinations of the northern states of Haryana, Uttar Pradesh, Uttarakhand, Bihar, Jharkhand, Rajasthan, Madhya Pradesh and Chhattisgarh.

The Jamia Hamdard Judicial Services Coaching facilitates you in conceptual building, understanding of knowledge, organization of facts, application of law in appropriate context and perspective besides encapsulating you the framework of jurisprudence and the institution of judiciary in India. But what matters ultimately is the students agility, captivity, positively and determination to achieve the goal.

The details of the proposed “Judicial Services Coaching Programme- 2023” are given hereunder-

DURATION OF PROGRAMME

20 Months with effect from July 2024 to February 2026.

NUMBER OF SEATS

The total number of seats shall be 60 including 5 seats reserved for the LL.M students.

ELIGIBILITY QUALIFICATION

(a) The candidates shall have to be from the **Minorities communities, Scheduled Castes, Scheduled Tribes and Women.**

(b) The **maximum age of the candidate shall not exceed to 35 years.**

(c) Any candidate **who-
possess a LLB degree**

OR

Studies in the Ninth or Tenth Semester of 5 year LLB degree course

OR

Studies in the third year of 3 year LLB degree course.

Hostel Facility

Presently, no hostel facility is available for the admitted candidates and the admitted students may themselves explore private P.G hostels in nearby areas of the University.

There is a likely availability of some select number of hostel seats in near future which shall be intimated with necessary details whenever situation arises.

LIBRARY

The library facility for all the Seven Days from 7:00 Am to 11:00 PM shall be available for both reading and issuance of books.

After depositing **Rs 1000/-** as fee for admission form the candidate may download **the prescribed application form (or on its typed version)** fill its each column. PROGRAMME FEE

(a)The non-refundable course fee for 20 months coaching programme is Rs 64,000/- @ Rs 3200/- per month which shall be payable in two installments-

(i) First installment of Rs 32000/- within 10 days of admission notification, and (ii) Second installment of Rs 32000/- in April 2025.

(b)In addition to that there shall be Security Deposit of Rs 2500/- which shall be refundable, shall be charged for one time for the entire duration of 20 months programme ending in April 2026.
