Detailed Qualifications and other Requirements:

- 1. Master's degree with at least 55% of the marks or an equivalent grade in a point scale wherever grading system is followed.
- 2. At least fifteen (15) years of experience as Assistant Professor in the Academic Level 11 and above or with eight (8) years' of service in the Academic Level 12 and above including as Associate Professor along with experience in educational administration.

OR

3. Comparable experience in research establishment and/or other institutions of higher education.

OR

4. Fifteen (15) years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

Desirable:

1. Preference will be given to candidates having CA/ICWA qualification and/or with experience in university/educational institute.

Age: Preferably below 55 years. Retirement Age: 62 years.

NOTE:

- 1) Total emoluments at the minimum of the pay scale including HRA, DA, TA shall be Rs. 2,53,922/-Per Month.
- 2) Officers belonging to the organized Audit and Accounts services shall be considered for appointment on deputation or re-employment basis. In such cases they should be working on an analogues post or 03 years regular service at Level-13 or 08 years regular service at Level -12. However the minimum qualification shall be relaxable at the discretion of the Competent Authority of Jamia Hamdard in exceptional cases.

- 1. The minimum qualification, pay and other benefits shall be as per the UGC/Statutory bodies/Jamia Hamdard norms.
- 2. Mere fulfilment of the minimum qualification and experience shall not entail a candidate to be short-listed for the interview.
