Bidders are requested to submit their bids in accordance with forwarding/covering letter as per Annexure-I of Notice Inviting Tender.

Any corrigendum/addendum regarding this tender will be available on the Jamia Hamdard website only.

ELIGIBILITY AND SELECTION CRITERIA:

The intending bidder should satisfy the following criteria: -

- 1. Should have minimum annual average turnover of Rs. 50.00 Lakhs during the last preceding three financial years ending 31st March, 2020. Documentary evidence(s) duly certified by a practicing Chartered Accountant (CA) must be attached.
- 2. Should have executed (03) Three similar works costing not less than Rs. 10.00 Lakhs.

OR

Two similar works costing not less than Rs. 15.00 Lakhs.

OR

One similar work costing not less than Rs. 20.00 Lakhs in Central Govt./State Govt. Department /Hospital/ Hotels etc.

The work order will be taken into consideration during the last three years upto 31st December-2020.

Certificate issued by Clients must be attached indicating the cost of work order and the period including time of completion. (Annexure-III). Copy of work orders and Copy of agreement etc. shall not be attached.

3. Should have minimum (03) three years of experience in similar work. The work order will be taken into consideration during the last three years upto 31st December-2020.

Certificate issued by client(s) must be attached indicating the period of work. Copy of work orders and Copy of agreement etc. shall not be attached.

4. Should have minimum average strength of 50 staff on rolls of the agency in last three consecutive years i.e. upto 31st December-2020.

Document duly certified by Chartered Accountant to this effect must be attached for the last three consecutive years.

Copy of Monthly Contribution Challan of EPF shall also be attached in the support.

5. The Bidder should have their Office(s)/workshop(s) in Delhi/NCR only.

The bids do not meet the above specified eligibility criteria and documents not submitted in conformity to the above shall be summarily rejected.

Note:

- The Jamia Hamdard reserves the right to restrict the number of firms for opening of financial bids, i.e. it may decide to open the financial bids of lesser than eligible bidder(s).
- Similar work means, specific work of Laundry Services.

GENERAL TERMS & CONDITIONS OF THE TENDER:

- 1. Sealed Tenders in prescribed form Proforma(s) duly filled must be submitted along with Bank Draft in favor of "Jamia Hamdard" amounting Rs.10,000/- as an Earnest Money and Rs.1000/- as Tender Fee, respectively.
- 2. The tender committee will open the tender on 31.03.2021 at 3.30 P.M in presence of interested tenderer/ representatives of bidders.
- 3. The contract is likely to commence from 01.04.2021 and would continue for a period of one year. The period of the contract may be further extended on mutually agreeable terms and conditions after the completion of contract, provided the requirement of the Majeedia Unani Hospital, Jamia Hamdard persists that time or may be curtailed/ terminated before the contract period owing to deficiency in service or substandard quality of laundry provided by the selected tenderer/agency or cessation of the requirement of work or due to any change in government policy/rules. The Jamia Hamdard, however, reserves the right to terminate this initial contract at any time after giving one month notice to the selected tenderer/agency.
- 4. Tenders not confirming the prescribed requirements and non-submission of required documents/ copies may be rejected and no correspondence thereof shall be entertained whatsoever.
- 5. The tender form should be clearly filled legibly or typed. The tenderer should quote the rates & amount tendered by him/them in figure & as well as in words. Alterations unless legibly attested by tenderer, shall disqualify the tender. The tender form should be signed by the tenderer himself. Self-Attested copies of the Registration Number of the firm, license no. under Contract Labours Act, Provident Fund Account no. (Allotted by Provident Fund Commissioner), ESI No. (allotted by the E. S. I. Department), GST No. and PAN CARD copy of the Income Tax Clearance Certificate, Satisfactory Performance Certificate issued by the concerned agency/Organizations.
- 6. No joint venture / consortium is allowed to participate in the Tender Process. Tenderer should submit an undertaking on firm's letter head in this regard.
- 7. No escalation of rates quoted will be allowed during the period of the contract.
- 8. The tenderer with seal of agency/firm should sign every paper of the tender as a confirmation of acceptance of the terms & conditions mentioned on the each paper. No column that is essentially required to be filled by the contractor, should be left blank, which would otherwise make the tender liable for rejection.
- 9. The preference can be given to those contractors who have related experience of providing laundry service to Hospitals.
- 10. The earnest money will liable to be forfeited, if the tenderer withdraws or amends & derogates from the tender in any respect within the period of validity of the tender.
- 11. Every amount paid to the contractor shall be subject to the deduction of Tax at source and other taxes as applicable from time to time by Govt. of India.
- 12. The tenderer/contractor shall deposit a Performance Security in favour of Jamia Hamdard for an amount of Rs. 30,000/- minimum or any higher amount as may be decided by the competent authority of Jamia Hamdard, either by Bank Guarantee or in the form of FDR for the due performance of the contract, within 15 days from the date of the contract. In the event of breach/ violation or contravention of any terms and conditions herein by the contractor, the said security deposit shall be forfeited by the Jamia Hamdard, in addition of any amount of penalty as decided by the Jamia Hamdard, shall be recoverable from

- security amount if not paid by the tenderer. The earnest money can be adjusted against security money. No Interest at all shall be paid on the earnest and security money deposited by the tendered.
- 13. Tenderer while submitting a tender would be presumed to have considered and accepted all the terms and conditions. No inquiry, verbal or written, shall be entertained in respect of acceptance or rejection of the tender.
- **14.** Any Act on the part of the tenderer to influence anybody in Jamia Hamdard is liable to rejection of his tender.
- 15. The contractor shall also require to obtain police verification of all their personnels/staffs/employees deployed at Majeedia Unani Hospital, Jamia Hamdard.
- **16.**The tenderer should have adequate facilities (infrastructure, qualified and expert manpower) for laundry service.
- 17. That the agency/contractor staff shall work under supervision, direction and overall administrative control of the Medical Superintendent or HOD concerned or any person deputed by Medical Superintendent.
- **18.**The Tenderer should not have defaulted in any payment of statutory dues like GST / EPF/ESI/Income Tax etc.
- 19. That the contractor shall have to produce documentary proofs i.e. Voter Card, Aadhar Card etc., in support of identity of the person deployed at Majeedia Unani Hospital.
- 20. That Majeedia Unani Hospital, Jamia Hamdard shall have the right to ask the contractor to remove any such person who is found undisciplined / mischievous / not competent in discharge of assign work.
- 21.In case any person engaged by the contractor is found to be inefficient, quarrelsome, infirm, and invalid or found indulging in unlawful or union activities, the contractor will have to immediately replace such person with a suitable substitute at the direction of the competent authority.
- 22. The institute shall not provide any sort of accommodation to the personnels/employees deployed by the contractor and no cooking/lodging at all shall be allowed in the premises of the institute at any time.
- 23.If any complaint of misbehavior and misconduct by personnel of the contractor comes into the knowledge of the institute authorities then responsibility for all such activities shall be of the contractor and any loss owing to negligence or mishandling by the personnel employed by the contractor, the contractor shall himself/herself be solely responsible to make good for the losses so suffered by the Institute.
- 24. The contractor shall not, at any stage, cause or permit any sort of nuisance in the premises of institute or do anything which may cause unnecessary disturbance or inconvenience to other working there as well as to the general public in the institute premises and near to it.
- 25. The person deployed by the contractor to perform duty shall wear proper Uniforms as prescribed and desired by Majeedia Unani Hospital, Jamia Hamdard, in clean & tidy conditions, and Identity card for which Jamia Hamdard shall not pay any extra amount to the contractor.
- **26**. That the agency shall not engage any sub-contractor or transfer the contract to any other person etc., in any manner whatsoever. If found subletting the contact can be terminated immediately including penal actions as deemed fit by Jamia Hamdard.
- 27. That the contractor shall at their own costs, employ/deploy staffs to render aforesaid support services to Majeedia Unani Hospital and the contractor shall be solely responsible for timely payment of their wages/salaries, remuneration and

other obligatory dues/benefits under any law for the time being in force, or which may come enforce, during currency of contract. The contractor shall comply with all the provisions of applicable labor laws and/or any other acts for which such personnels are subjected to and shall keep Jamia Hamdard indemnified from all such acts, omissions, faults, breaches and / any claims, payments, losses, demands, injuries, and expenses etc. in connection with such personnel deployed by the contractor. Jamia Hamdard will not be responsible for such acts, omissions, faults, breaches and/any claims, payments, loss, demands, injuries, and expenses etc.

- 28. In case of unsatisfactory services, the contract can be terminated by Jamia Hamdard by giving one month notice. The contractor if so desire to terminate the contract will be required to give one month notice or till institute is able to make alternative arrangements, whichever is later.
- 29. In case of any attempt for cartelization by bidder with a view to hike up the prices, all bids will be rejected and such bidders will be blacklisted and bid security will be forfeited.
- 30. The contractor shall not engage any personnel below the age of 18 years and this shall be the sole responsibility of the contractor only. All the personnel deployed by the agency shall be medically fit and their antecedents be verified prior to the deployment in the Institute. The age of Outsource Staff shall be preferably upto 45 years.
- 31. Any liability arising out of any litigation (including those in consumer courts) clue to any act of contractor's personnel, the same shall be directly borne by the contractor including all the compensations/damages/expenses/fines etc. The concerned contractor personnel shall attend the court as and when required.
- **32**.If as a result of 'post payment audit' any overpayment is detected in respect of any work done by the agency or alleged to have been done by the agency under the tender, it shall be recovered by the 'Institute' from contractor.
- 33. The contractor shall be solely responsible for all acts of omission/commission in the institute by their employees during the course of discharge of their duties at the institute. Majeedia Unani Hospital, Jamia Hamdard will not be responsible for any mishap while dealing with the laundry work during the described scope of work because of such acts of omission/commission.
- 34. Persons suffering from contagious or infectious diseases shall not be employed or permitted to work in Majeedia Unani Hospital, Jamia Hamdard. The Jamia Hamdard authorities reserve its rights to examine any of the employees for medical fitness without prior notice. Expenses, if any incurred by the Hospital on medical examination of such employees, shall be borne and paid by the bidder/vendor.
- 35. The contractor will be solely responsible for the compliance of all statutory regulations applicable to the contractor/labour as also other Central & State Government statutory regulations associated with such work. If on account of non-compliance with the provisions of any such laws, Jamia Hamdard is called upon to make any payment to or in respect of his employees, the contractor shall fully reimburse and indemnify to the Institute all such payment and Institute shall be free to make deductions on this account from the amount of Security Deposit, in which case, the contractor shall immediately pay to the Institute such amount as may be necessary to make up the required security Deposit, or from the dues which may be payable by the Institute to the contractor. The contractor will sign an Indemnity Bond in favor of Jamia Hamdard, to this effect. No liability whatsoever shall attach to the Jamia Hamdard on account for any failure on the

part of the contractor to observe these regulations.

- 36. The personnel deployed shall be employees of the contractor and all statutory liabilities such as ESI, EPF, Workmen's compensation as per relevant statutory Act, etc. shall be paid by the contractor. List of personnel deployed shall be provided by the contractor well in advance.
- 37. The bid submitted by the bidder and all subsequent correspondence and documents relating to the bid exchanged between the bidder and the purchaser, shall be written in the English language.
- 38. The bidder shall bear all costs and expenditure incurred and/or to be incurred by it in connection with its bid including preparation, uploading of its bid and for subsequent processing the same. The purchaser will, in no case be responsible or liable for any such cost, expenditure etc. regardless of the conduct or outcome of the Tender process.
- **39.**Subject to the above, the Contract will be awarded to the lowest evaluated responsive bidder.
- 40. The resultant contract will be interpreted under Indian Laws. In the event of any dispute arising out of this tender/contract/agreement or in connection with the interpretation of any clause in the terms and condition of the tender/agreement/contract or otherwise, the matter shall be referred to the arbitrator appointed by the Vice-Chancellor of Jamia Hamdard with the mutual consent of the contractor and the seat and venue of the arbitration proceedings shall be New Delhi/Delhi only.
- **41.**Courts at Delhi/New Delhi shall have bot the pecuniary and territorial jurisdiction in connection with any disputes/litigations etc., arising between the parties concerned to the given Contract/Agreement.

- 7. Jamia Hamdard shall reserve the right to bi-furcate the whole work, allot to more than one contractor or reject any/all the tenders without assigning any reason, whatsoever.
