ORDER

Whereas Prof. Mridu Dudeja, Department of Microbiology, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard, New Delhi was placed under suspension vide Order No. JH/RO/HIMSR/2024/DE/ICOR/12 dated 22.1.2024 for alleged misconduct and insubordination of orders of her superiors and the authorities of Jamia Hamdard by the Vice Chancellor under sub-rule (1) of Rule 10 of CCS (CCA) Rules, 1965.

And whereas it was also ordered that during the period of her suspension, the Headquarters of Prof. Mridu Dudeja shall be the office of the Registrar.

And whereas yesterday i.e. 4th Feb, 2024/08.00 PM, she had reportedly circulated a mail in the HIMSR faculty group by using the official email ID of the office of the Dean, HIMSR, JH [dean@himsr.co.in] and representing herself as the Dean, HIMSR. She also issued illegal orders directing that *"all the orders to the faculty or employees must come through her or through a person authorized by her, in writing"*.

And whereas today i.e. 5th Feb, 2024, the said Prof. Mridu Dudeja also reportedly called an illegal meeting in HIMSR main building with Prof. Musharraf Husain, Medical Supdt. HAHCH, all the Heads of the Departments and all professors of HIMSR at 10.15 AM in the College Council Room regarding the current position of HIMSR and HAHCH Hospital again representing herself as Dean/Principal, HIMSR.

And whereas the above irresponsible conduct and misrepresentation as Dean/Principal, HIMSR, Jamia Hamdard by Prof. Mridu Dudeja has led to an utter confusion and chaos in the HIMSR/HAHCH of Jamia Hamdard campus, New Delhi all through the day.

And whereas, the said Prof. Mridu Dudeja has reportedly signed several official papers including some related to conduct of MBBS/MS/MB Examinations as Dean/Principal, HIMSR in an illegal and irresponsible manner and risking the students' academic career with ill motive.

And whereas, the above irresponsible and illegal act and conduct on the part of Prof. Mridu Dudeja not only is unwarranted but also has disrupted the normal functioning of the Jamia Hamdard in general and HIMSR/HAHCH in particular and has also created a law-and-order problem.

Now, therefore, the Vice-Chancellor in order to maintain proper discipline and orderliness in the Jamia Hamdard campus, in exercise of his general powers conferred to him under Clause 23 C. (7) of the UGC (Institutions Deemed to be Universities) Regulations, 2023 hereby restricts the entry of said Prof. Mridu Dudeja, in the Jamia Hamdard Campus, for a period of one month or until further orders whichever is earlier in the larger public interest with immediate effect.

It is also ordered that she may enter the Jamia Hamdard Campus only with the prior approval from the Registrar or the Vice-Chancellor.

A signed copy of this order shall be served to Prof. Mridu Dudeja by all modes.
