AUCTION NOTICE

Subject:-**Disposal of condemned University vehicles**

1. Office of the Registrar, Jamia Hamdard, New Delhi-110062, is proposing to dispose off two university vehicles on “**as is where basis is**”. Details of the said vehicles is as under:-

2. Accordingly, sealed quotations are invited from **authorized dealer/individual** for the disposal of the said vehicles on the terms and conditions mention below. Persons/firms, interested in purchasing the above mentioned vehicles, may submit their bid in the enclosed Performa in a sealed cover addressed to the undersigned latest by 3.00 PM on or before 10th July, 2023 in Purchase section Room No.06, Jamia Hamdard. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of Quotations. The cover should be prominently superscripted with the words “**QUOTATION FOR PURCHASE OF VEHICLE**”.

3. The vehicles will be available for inspection between 3.00 PM to 5.00 PM on any working dauy.

4. The Auction of the said vehicles will be governed by the following terms and conditions:-

- (i) The vehicles will be auctioned separately for each vehicle, not through the lot.
- (ii) The vehicles will be sold on “**As is where basis is**”. The auction process will be conducted in presence of Disposal of “Auction Committee”.
- (iii) The bidders are required to pay Earnest Money as follows:-

- (iv) Earnest Money is payable by means of Demand Draft drawn in favour of “**Registrar Jamia Hamdard**” payable at New Delhi (Payment by cheque or cash shall not be accepted).
- (v) Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.

- (vi) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of “**Registrar Jamia Hamdard**” payable at New Delhi within seven working days of the acceptance of bid.
- (vii) The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again taken up for re-auction.
- (viii) The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).
- (ix) The auctioned vehicles will be removed by the successful bidder within 05 working days of depositing the bid amount, at their own expenses.
- (x) The vehicles will be disposed off on “**as is where basis is**” and “**No Guarantee**” for its worthiness or quality will be given by the Jamia Hamdard.
- (xi) Jamia Hamdard will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicles for commercial or any other purpose after sale.
- (xii) If, the successful bidder wants to “**scrap**” the vehicle, then he should have to submit the cut part of the chassis number to Jamia Hamdard immediately.
- (xiii) The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- (xiv) The Bid amount is excluding GST, as the GST is to be paid by the recipient of the vehicle/goods as per the rates applicable.
- (xv) The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
