UNIVERSITY ORDER

The Vice Chancellor has been pleased to approve the following schemes of incentive for high quality publications by the faculty and research scholars of the University.

1. Publication in high impact factor journals

Criteria:

- a) Publication to be from the original research work conducted at Jamia Hamdard.
- b) Reviews will not be considered.
- c) The Jamia Hamdard faculty/research scholar should either be the first author or corresponding author.
- d) The impact factor should be 3 or above (Science Citation or Social Science Index ranking) at the time of application.
- e) Publication(s) resulting from collaboration under MoU leading to Ph.D. Degree will not be considered for this scheme.

Incentive:

Rs. 5000 per paper in a journal with impact factor more than 5 and Rs. 2000 for the paper published in journal with impact factor 3 but less than 5. There is no limit for claim of incentive in a year.

University may also give a citation and award such incentive on the special occasions such as Founder's Day (14th September) or National Science Day (28th February).

Procedure:

A hard copy as well as soft copy will be required to be submitted to the Office of Advisor (Research) within one month of publication of paper along with full citation i.e. page number, volume and year. Papers *in press* will not be considered.

This scheme will apply to the papers published in 2010 onwards.

2. Reward for highly cited publication

Criteria:

- a) Publication to be from the original research work conducted at Jamia Hamdard.
- b) Reviews published in indexed journals will also be considered.

- c) The Jamia Hamdard faculty/research scholar should be the first author or corresponding author.
d) Self citation will not be counted.

Incentive:

- Rs. 1000 per paper for every citation of minimum of 10.
- Rs. 5000 per paper with citation of 51 and above.

Incentive for the same paper may be considered up to the maximum of category (ii) as mentioned above. Once this incentive has been availed, the same paper will not be considered for further incentive.

Incentive for citation will be rewarded to the papers published in 2010 onwards.

University may also give a citation and award such incentive on the special occasions such as Founder's Day (14th September) or National Science Day (28th February).

Procedure:

A citation detail will be required to be submitted to the Office of Advisor (Research) at the end of each calendar year (by March 31). University may verify the citation detail.

Financial Provision:

Financial provisions for the above rewards will be made partly from the Overhead Expenses of the projects (50%). Remaining contribution (50%) will be made from the SFS funds. The Advisor (Research) shall explore additional resources from within and outside Jamia Hamdard.

The above schemes may please be widely publicised.
