## TERMS AND CONDITIONS

- 1. The Tender can be downloaded from 23<sup>rd</sup> May.2016 to 10<sup>th</sup> Jun- 2016 till 3:00 p.m.
- 2. Last date for the submission of tender forms is10<sup>th</sup> Jun- 2016 till 3:00 p.m. Tenders should be duly filled and complete in all respects otherwise they will be rejected.
- 3. Tenders will be opened on 10<sup>th</sup> Jun- 2016 till 3:30 p.m at in the Purchase Section, basement, Administration block.
- 4. The successful contractor shall have to make the following payments:
  - (i) Earnest money Rs. 5,000.00 (Rs. Five thousand only), refundable.
  - (ii) Security Deposit Rs. 25,000.00 (Rs. Twenty Five thousand only).
- 5. Earnest money, which is to be given along with this tender, would be refunded. Only bank draft in favor of "Registrar, Jamia Hamdard" shall be accepted.
- 6. Throughout the period of AMC, university representative will check the operation of the system.
- 7. It will be the responsibility of the agency to depute trained and skillful man power at site for up keeping the serviceability of the Fire hydrant systems fitted in Jamia Hamdard.
- 8. The agency shall be responsible for the discipline and conduct of the manpower deployed at site.
- 9. The university will not be responsible for any case including the payment due to damage or accident caused by the manpower deployed at Jamia Hamdard.
- 10. Payment will be made by the university on the receipt of bill duly verified by the university official after deduction of tax at source as applicable.
- 11. The maintenance staff will make a record of all maintenance activities in a maintenance log book supplied by the contractor which will be inspected by the representative of Jamia Hamdard from time to time.
- 12. The maintenance staff should carry their Identity Card while at Jamia Hamdard.
- 13. During the maintenance activity if any, contractor should take all possible safety precautions at site to avoid any unfortunate situation.
- 14. Time limit for functioning of all fire hydrant system, line & water sprinkler and fire smoke detections systems will be two months only from the date of award of work order and AMC cover for one complete year.
- 15. Jamia Hamdard does not bind himself to accept the lowest or any tender and reserves to himself right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
- 16. The tenderer shall quote rates both in figures and words. He shall also workout the amount for each item of work and writes in both figures and words.
- 17. Any discrepancy due to incomplete description ambiguity omission in the installation and other documents whether original or supplementary during the contract of the AMC, the contractor immediately on observing the same can draw the attention of the representative. The representative's decision will be final and binding on the contractor. In general the AMC of Fire Fighting System shall strictly conform to the Berauo of Indian Standard

- 18. The contractor shall provide all the consumable material at his own cost.
- 19. In the event of failure of any particular part of any equipment more than three times during the AMC or defects liability period. It shall not be repaired but the complete part shall be replaced by the contractor and the guarantee for this particular part shall be extended by one year from the date of last replacement.
- 20. In lieu of rectification of work not done in accordance with the contract, Jamia Hamdard may hold 25% of the AMC value till the completion of work duly certified by the representative of Jamia Hamdard.
- 21. No compensation shall be claimed from Jamia Hamdard under any condition for any type of loss or damage to the man and material of the contractor at site.
- 22. The periodical functional test will be carried out by the contractor in the first week of every month and to be submitted the check list to the representative of Jamia Hamdard.
- 23. Before tendering, the tenderer shall inspect the site to fully acquaint himself about the condition in regard to accessibility of site, nature and extent of ground, working condition of site and locality including stocking of materials, Installations of tools and plants (T&P) etc., and movement of labour etc. required for the satisfactory execution of the work contract. No claim whatsoever on such account shall be entertained by Jamia Hamdard in any circumstances.
- 24. The tenderers are advised to inspect the site to ascertain the nature of site, access, location, facilities for tracking down of materials. The tenderer shall have full knowledge of the site.
- 25. Any emergency/urgency needs of site to be attended within two hours of information.
- 26. The contractor should sign each and every paper as an acceptance of terms and conditions of the tender.
- 27. In the event of any dispute arising out of the final agreement between Jamia Hamdard and the agency during the continuance of agreement, relating to interpretation of terms and conditions of the agreement, shall be referred to the Sole Arbitrator appointed by Vice Chancellor of Jamia Hamdard in consultation with the agency and the decision of the arbitrator shall be final and binding upon both the parties.
