Jamia Hamdard- Silver Jubilee Research Fellowships

The Competent Authority of Jamia Hamdard has approved the following with respect to implementation of the above Fellowships.

- 1. The Silver Jubilee Research Fellowship will be awarded for a tenure of three years. The fellowship shall cease from the proceeding month when thesis is submitted even before completion of three years. For example, if a fellow submits thesis in on August 17, 2018. He/she will get fellowship up to August 31, 2018 and will cease to get fellowship from September 1, 2018.
- 2. A fellow selected for Silver Jubilee Fellowship will be offered Rs. 25000 (fixed with no other allowances). His/her fellowship amount will be increased to Rs. 35000 in case he/she qualifies NET-JRF. This means that he/she will get additional amount of Rs. 2500 pm over and above the JRF amount he/she will get from UGC/CSIR/ICMR etc. This additional amount will be further enhanced to Rs. 5000 pm when he/she is promoted to SRF of UGC/CSIR/ICMR etc. The amount of fellowship of the existing fellows selected in 2017 series will also be revised accordingly as per above criteria.
- 3. The provision of additional amount will not be applicable in case a fellow is selected for a national fellowship with amount (including HRA) higher than or equal to that mentioned above (i.e. Rs. 35000 pm).
- 4. The above provision of fellowship rates will be implemented w.e.f. September 1, 2018 and will be applicable to existing as well as newly selected Silver Jubilee Research Fellows.
- 5. No change is proposed in the fellowship amount of Silver Jubilee Post-doctoral Fellowship and amount of Contingency grant.
- 6 The contingency will not be allowed to be used for attending conferences/seminars/workshops (in Indian or abroad). No registration fee could be claimed from the contingency.
- 7. The candidates who have been selected for Silver Jubilee Research Fellowship, if not already enrolled for Ph.D. programme in Jamia Hamdard will be given opportunity of admission to Ph.D. programme in the relevant stream in the current academic session. They will be given access to apply and their admission will be processed along with other candidates. A candidate selected for Silver Jubilee Research



Fellowship will be required to mandatorily register for Ph.D. programme at Jamia Hamdard on full time basis.

8. The clause related to refund of fellowship/contingency in case a candidate leaves in between is withdrawn. However, a fellow will be required to give one month's advance notice. The advance notice will be given to Supervisor/Mentor which will be forwarded to the Advisor (Research) Office.

The fellowship shall cease from the proceeding month when thesis is submitted even before completion of three years. For example, if a fellow submits thesis in on August 17, 2018. He/she will get fellowship up to August 31, 2018 and will cease to get fellowship from September 1, 2018.
- 2. A fellow selected for Silver Jubilee Fellowship will be offered Rs. 25000 (fixed with no other allowances). His/her fellowship amount will be increased to Rs. 35000 in case he/she qualifies NET-JRF. This means that he/she will get additional amount of Rs. 2500 pm over and above the JRF amount he/she will get from UGC/CSIR/ICMR etc. This additional amount will be further enhanced to Rs. 5000 pm when he/she is promoted to SRF of UGC/CSIR/ICMR etc. The amount of fellowship of the existing fellows selected in 2017 series will also be revised accordingly as per above criteria.
