- 2. The tenders should be submitted in sealed covers. Open tenders will be rejected.
- 3. Tender opening committee will open the Tender on 28-11-16 at 3.30 P.M. in the office of the Estate Officer in presence of available interested tenderers/auctionists.
- 4. The tender form should be clearly filled in ink legibly or typed. The tenderer/auctionist should quote the amount tendered by him/them in figure & as well as in words. Alterations unless legibly attested by tenderer/ auctionist, shall disqualify the tender. The tender form should be signed by the tenderer/ auctionist himself. - 7. The tenderer should take care that the amount should be written in such a way that interpolation is not possible. Tenders should clearly quote their rates per unit as asked for both in figures and in words inclusive of all taxes and duties if any. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
- 8. The address given in the tender shall be deemed to be the renderer's address and correspondence sent on that address shall be considered to have been delivered to the tenderer.
