1. The Unit should be useful for Static & Dynamic assessment.
2. The unit should measure force, force distribution & movement of the patient.
3. The equipment should be suitable for upper and lower extremities training therapy
4. Should be able to do presentation of weight distribution in bimanual supporting, functional free sitting, symmetrical weight distribution and trunk and pelvis activities.
5. Should be useful for the improvement of active knee control, weight transfer, development of muscular strength and coordination of lower extremities & postural musculature
6. Software should have the interactive therapy games for coordination
7. Software should generate the report with progress diagram including all data.
8. The system should have feature of connecting through blue tooth to computer for wire free use of the unit for lower limbs/upper limbs/core muscles.
9. The unit should be supplied with the suitable configuration of the Desktop computer for the full operation of the system
