Prof. V. Ramgopal, Prof. Abad Ahmad, Prof. Y.K. Gupta and some internal members could not attend the meeting due to their prior engagement and were granted leave of absence.

The meeting started with the recitation of the verse from holy 'Quran' by Imam, Rabia Mosque.

The Chairman welcomed all members especially those faculty members who have been promoted as Professor and attended the meeting in this capacity.

After that the Chairman briefed the house about the ongoing academic advancement made, specially award of UGC-FIST to seven departments of Jamia Hamdard.

The House appreciated the efforts made by the faculty members and acknowledged the contribution made by the Vice-Chancellor in terms of providing best support to the Departments/Schools despite financial crunch and limited resources. The Chairman, further, suggested to the concerned Deans, HoDs and Faculty members to inform Prof. S. Raisuddin if they submit any projects for grants to enable him to maintain these information in a centralized place.

The Chairman also briefed the house that during the last week of February, Jamia Hamdard conducted a successful event 'Jashne-Adab' wherein large no. of poets, artists and eminent personalities of the Indian Film Industry were invited. On 4th March, 2019, Jamia Hamdard conducted a special convocation to confer 'Honoris Causa' to the renowned Poet, Lyricist and Play Writer, Mr. Javed Akhtar. The AC felt that such events could provide a branding and visibility overall to 'Jamia Hamdard' across the India and thereby enhancing its perception. AC 39 (13): TO CONSIDER THE PROPOSAL OF DEAN, SCHOOL OF OPEN AND DISTANCE LEARNING REGARDING REVISION OF EXAMINATION FEE FOR BACKLOG STUDENTS, ADOPTING SYLLABUS OF BBA AND BCA PROGRAMS OF REGULARS STUDENTS FOR THE ODL STUDENTS AS WELL AND OFFERING PG DIPLOMA IN BAKERY AND CONFECTIONERY TECHNOLOGY

Dean, SODL briefed the house on the issues pertaining to DEB-UGC's directives for BBA and BCA courses run through ODL mode at par with the course structure examination pattern and conduct of examinations with BBA and BCA offered by Jamia Hamdard in regular mode.

Dean, SODL ensured the house that all possible steps are being/will be taken to strengthen our courses and to attract more students in the current academic session 2019-2020.

*AC, after deliberations, resolved to approve as under:

- Reduction of examination fee for the ODL students only for reappearing in the backlog papers from Rs. 2000/- per paper to Rs. 1000/- per paper with immediate effect.
- 2. To comply with the guidelines of the DEB-UGC, adoption of the syllabus of BBA and BCA programs of Jamia Hamdard being taught to the regular students will also be applicable for BBA and BCA programs offered through distance mode with immediate effect from July 2019 session. These programs would also be offered in the semester mode and their examinations would also be conducted, simultaneously, along with the regular students with common question papers for the BBA and BCA programs for the regular as well as ODL students.
- Introduction of One Year Post Graduate Diploma in Bakery and Confectionery Technology under the Department of Food Technology, through open and distance learning from the academic session 2020-2021."

AC 39 (14): TO CONSIDER THE PROPOSAL OF ASSISTANT REGISTRAR (RECRUITMENT) WITH REGARD TO LOOK INTO THE PRESENT FACULTY RECRUITMENT SYSTEM AT JAMIA HAMDARD IN THE LIGHT OF UGC'S REGULATIONS 2018 ON THE CRITERIA TO SELECT TEACHERS FROM JANUARY 2021 ONWARDS.

Some members were of the view that we should request the UGC to include the subject of Pharmaceutical Sciences to conduct NET. It was also brought to ACs notice that as per INC norms, the highest qualification to induct faculty is Masters with PhD as desirable. There may be at variance with the UGC norms for faculty recruitment.

"After deliberation, the AC resolved to approve the proposal in principle as brought out in the agenda item. Further, resolved that University may seek clarification from the UGC regarding recruitment norms of statutory bodies such as INC, PCI, RCI, CCIM etc. where highest qualification required at the level of Assistant Professor is Masters; and not PhD."
