The Learned Arbitrator Justice Badar Durrez Ahmed (Retd.) & former Chief Justice, High Court of Jammu & Kashmir, the Sole Arbitrator in the Arbitration between Mr. Asad Mueed & Another Vs Hammad Ahmed & Others Vs Hammad Ahmed & Others in the proceedings of the 30<sup>th</sup> sitting of the Arbitral Tribunal held on 19.1.2024, in his order that the Claimants (namely Mr. Asad Mueed and Mr. Abdul Majeed Sani) are permitted to enter inside the Jamia Hamdard premises.
