OFFICE ORDER

It has come to the notice of the University Administration that Prof Mridu Dudeja (Under suspension), Department of Microbiology & former Dean, Hamdard Institute of Medical Sciences & Research, Jamia Hamdard has called an illegal meeting of all Heads of Department of different Departments of HIMSR along with faculty members today initially at 12.00 Noon and later postponed to 3.00 pm today in the Lecture Theatre-I, HIMSR building.

- 2. All the HoDs of HIMSR and Medical Supdt/Addl. Medical Supdt. of HAHCH of JH and other staff posted HIMSR/HAHCH are advised not to take cognizance of such meeting as Prof. Mridu Dudeja has been placed under suspension pending departmental enquiry and she cannot perform any official function during the suspension period.
- 3. Further, it is also notified to all concerned that the five-year tenure of Dr. G.N. Qazi as Director General of HIMSR, JH also came to end on 13.8.2021 and he ceased to be in the associated with the Jamia Hamdard, New Delhi.
- 4. All concerned are, therefore advised to keep themselves away from such meetings called by a suspended employee of HIMSR Jamia Hamdard or any official dealings with Dr. G. N. Qazi, Ex Director General, HIMSR, JH.
- 5. Copies of orders of suspension of Prof. Mridu Dudeja issued by the University dated 22.1.2024 and Order dated 19.1.2024 about the ending of term of Dr. G. N. Qazi are enclosed herewith for the information of all concerned.
- 6. Deviation, if any by any faculty or staff of HIMSR/HAHCH shall be viewed seriously by the University Administration and they shall be liable for disciplinary action as per the Jamia Hamdard Service rules.

OFFICE ORDER

On his completion of tenure as Vice Chancellor of Jamia Hamdard from 13.10.2008 to 13.08.2016, the services of Dr. G.N. Qazi were engaged by the Jamia Hamdard as Director General at Hamdard Institute of Medical Sciences and Research (HIMSR) for a period of five years w.e.f. 14.8.2016 vide Order No. JH/RO/UO/2016/48 dated 12.8.2016 with certain specific roles and responsibilities to strengthen the functioning of the HIMSR as per the decision taken in the 3rd Meeting (Emergent) of the Board of Management held on 26.4.2018.

It has been brought to the notice of the Finance Committee and the BOM/Executive Council of the Jamia Hamdard that Dr. G. N. Qazi after superannuation from the services of the Indian Institute of Integrative Medicine (IIIM), Jammu-Tawi, an CSIR institution under the Government of India has drawn full salary without deduction of his pension during his tenure as Vice Chancellor in violation of the Govt. of India, UGC rules as applicable to Jamia Hamdard being a UGC funded Institution.

Though his tenure of five years ended on 13.8.2021, he is still associated with the affairs of the HIMSR/HAHCH, JH without the due approval of the competent bodies of the Jamia Hamdard constituted in terms of the UGC (Institutions Deemed to be Universities) Regulations as amended from time to time in an illegal manner.

Hence, it is notified to all concerned that after completion of his five years tenure on 13.8.2021 as Director General, HIMSR, Jamia Hamdard, New Delhi, Dr. G.N. Qazi ceased to in the services of Hamdard Institute of Medical Sciences & Research and its associated Hospital i.e. Hakeem Abdul Hameed Centenary Hospital of Jamia Hamdard.

ORDER

Whereas a disciplinary proceeding against Prof. Mridu Dudeja, Department of Microbiology, Hamdard Institute of Medical Science & Research, Jamia Hamdard, New Delhi is contemplated for alleged misconduct and insubordination of orders of her superiors and the authorities of the Jamia Hamdard.

Now, therefore, the Vice-Chancellor of the Jamia Hamdard, in exercise of the powers conferred by bylaws/MOA and UGC (Institutions Deemed to be Universities) Regulations as amended from time to time read with sub-rule (1) of Rule 10 Central Civil Services (Classification, Control and Appeal) Rules, 1965, clause 65 of the Jamia Hamdard Calendar read with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018 as applicable to teachers of Jamia Hamdard, hereby places the said Prof. Mridu Dudeja under suspension with immediate effect i.e. 22.1.2024 (AN), pending departmental enquiry.

It is further ordered that during the period that this Order shall remain in force the HQrs of Prof. Mridu Dudeja, Department of Microbiology, Hamdard Institute of Medical Science & Research, Jamia Hamdard shall be the Office of the Registrar and she shall not leave the HQrs without obtaining the previous permission of the Vice-Chancellor.

Orders regarding subsistence allowance admissible to her during the period of her suspension will be issued separately.
