ORDER

Whereas a disciplinary proceeding against Prof. Musharraf Husain, Department of Surgery and presently functioning as Medical Superintendent, Hakeem Abdul Hameed Centenary Hospital, Hamdard Institute of Medical Science & Research, Jamia Hamdard, New Delhi is contemplated for alleged misconduct, insubordination of orders of his superiors and violation of lawful orders of the Jamia Hamdard authorities, financial impropriety, restraining the Head Cashier of HIMSR/HAHCH, JH from collection of cash for deposit in the Jamia Hamdard accounts etc.

Now, therefore, the Vice-Chancellor of the Jamia Hamdard, in exercise of the powers conferred by bylaws/MOA and UGC (Institutions Deemed to be Universities) Regulations as amended from time to time read with sub-rule (1) of Rule 10 Central Civil Services (Classification, Control and Appeal) Rules, 1965, clause 65 of the Jamia Hamdard Calendar read with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018 as applicable to teachers of Jamia Hamdard, hereby places the said Prof. Musharraf Husain under suspension with immediate effect i.e. 6.2.2024 (FN), pending departmental enquiry.

The said Prof. Musharraf Husain is also stand relieved from the charge/responsibilities of Medical Superintendent of HAH Centenary Hospital with immediate effect.

Further, the Vice-Chancellor in order to maintain proper discipline and orderliness in the Jamia Hamdard campus, in exercise of his general powers conferred to him under Clause 23 C. (7) of the UGC (Institutions Deemed to be Universities) Regulations, 2023 hereby restricts the entry of said Prof. Musharraf Husain, in the Jamia Hamdard Campus, for a period of one month or until further orders whichever is earlier in the larger public interest with immediate effect. It is also ordered that he may enter the Jamia Hamdard Campus only with the prior approval from the Registrar or the Vice-Chancellor.

It is also ordered that after the expiry of period of restricted entry into the Jamia Hamdard campus, the HQrs for the suspension period of Prof. Musharraf Husain, Department of Surgery, Hamdard Institute of Medical Science & Research, Jamia Hamdard shall be the Office of the Registrar and he shall not leave the Headquarters without obtaining the previous permission of the Vice-Chancellor. Orders regarding subsistence allowance admissible to him during the period of suspension will be issued separately.

A signed copy of this order shall be served to Prof. Musharraf Husain by all modes.


