

### The primary objectives of the IQAC as per NAAC guidelines are-

- (i) To promote quality culture as the prime concern of the Jamia Hamdard through institutionalizing and internalizing all the quality-enhancing and sustaining initiatives taken with internal and external support.
- (ii) To develop a mechanism to promote conscious, consistent and catalytic action plans to improve the academic and administrative performance of the institution.
- (iii) To promote institutional quality enhancement and sustenance through the internalization of quality culture and institutionalization of the best practices.

#### 3. The broad functions of the IQAC are-

- a) Development and application of quality benchmarks;
- b) Setting parameters for various academic and administrative activities of the JH;
- Facilitating the creation of a learner-centric environment conducive to quality education and faculty development to adopt the required knowledge and technology for participatory teaching and learning process;
- d) Collection and analysis of feedback from all the stakeholders on quality-related institutional processes;
- e) Dissemination of information on various quality parameters to all the stakeholders;
- Organization of intra- and inter-institutional workshops and seminars on quality related themes and promotion of quality circles;
- g) Documentation of various programmes/activities leading to quality improvement;



- h) Acting as a nodal agency of the JH for coordinating quality-related activities, including adoption and dissemination of the best practices;
- Development and maintenance of institutional database through MIS for the purpose of maintaining and enhancing institutional quality;
- j) Periodical conduct of Academic and Administrative Audits along with their follow-up activities;
- k) Preparation and submission of the Annual Quality Assurance Report (AQAR) as per the guidelines and parameters of NAAC; and
- to submit the AQAR to the Academic Council/BOM/Executive Council from time to time for quality evaluation purpose.

#### Tenure of the IQAC:

The tenure of the members of the IQAC except the ex-officio members shall be for a period of two years from the date of this notification.

#### Meetings of the IQAC:

The IQAC shall meet at least **once in a quarter**. The quorum for the Meeting shall be 2/3<sup>rd</sup> of the total number of members. The Director, IQAC being the Member Secretary shall be responsible to maintain proper Minutes electronically in a retrievable form and to be uploaded on the JH website-IQAC webpage from time to time.
