The terms of appointments of above Adjunct Professors/ Faculty will be as under:

- a) The above appointments are purely honorary in nature and without any remuneration. However, the appointees shall be paid honorarium, sitting fee for meeting(s), and other applicable allowances with respect to their specified active contribution in teaching and research, as per University norms.
- b) Adjunct Professors / Adjunct Faculty may be actively involved in the School Board, Research Advisory Committee, Board of Studies, and other relevant Boards and Committees as members. They may also be invited to meetings of these bodies as *Special Invitees*, including during visits of the NAAC Peer Team and other regulatory Councils.
- c) Adjunct Professors / Adjunct Faculty are expected to visit Jamia Hamdard at least once a year to deliver lectures and interact with Ph.D./PG students. For such visits, they shall be provided local hospitality at the Scholars' House and TA, for a maximum of two visits per year.
- d) Adjunct Professors / Adjunct Faculty may act as Mentors to Ph.D./PG students.
- e) An Adjunct Professor / Adjunct Faculty shall have no conflict of interest with any of the activities of Jamia Hamdard, including those of the Sponsoring Body.

Director IQAC and Heads/ Deans of respective Departments/Schools are requested to kindly take necessary action and inform the above Adjunct Professors/Faculty accordingly.
