In accordance with the provisions contained in the University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018, notified in the *Gazette of India*, and in continuation of the University Notification dated 24 January 2025 regarding reconstitution of the Institutional Academic Integrity Panel (IAIP), the Institutional Academic Integrity Panel (IAIP) of Jamia Hamdard is hereby reconstituted as under for a period of three (03) years:

Functions and Mandate

1. The Departmental/School Academic Integrity Panels (DAIP) shall continue to investigate cases of plagiarism at the Department/School level.
2. The Institutional Academic Integrity Panel (IAIP) shall examine and recommend appropriate decisions on plagiarism complaints investigated by the DAIP and shall communicate its recommendations/decisions to the R&D Cell.
3. The Committee on Integrity in Research/Academics (COIR), constituted by the R&D Cell in accordance with the UGC Guidelines for Establishment of Research and Development Cells in HEIs, 2022, shall continue to deliberate on all issues of academic and research misconduct, including conflict of interest, plagiarism, and other ethical issues.
4. The COIR shall also review the recommendations/decisions of the IAIP and submit its recommendations to the Research Advisory Council (RAC), chaired by the Hon'ble Vice Chancellor.

The tenure of the Institutional Academic Integrity Panel (IAIP) shall be three (03) years from the date of issue of this Notification. The quorum for a meeting shall be three (03) out of four (04) members.
