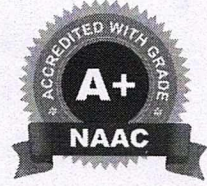

**Sub: CONSTITUTION/RECONSTITUTION OF ANTI RAGGING COMMITTEE

The Vice Chancellor is pleased to constitute/reconstitute the Anti Ragging Committee (ARC) for the Jamia Hamdard, New Delhi with immediate effect in compliance with UGC Regulations on Curbing the Menace of Ragging in HEIs, 2009 as notified in the Official Gazette dated 17th June 2009 for the current and new academic session 2023-24 & 2024-25 or until further orders whichever is earlier: -

- i) Chief Proctor - Chairman
- ii) Dean Student Welfare - Member
- iii) Provost (Boys) Hostel
- iv) Provost (Girls) Hostel
- v) Sub-Divisional Magistrate, Kalkaji (South-East District) (Civil Admn. Representative)
- vi) Station House Officer (Police Representative)
- vii) One NGO Member (to be nominated by the Vice Chancellor)
- viii) One Media Member (to be nominated by the Vice Chancellor)

2. ARC shall be responsible for the following: -

(i) The ARC is to ensure compliance with the provisions of the Regulations as well as the provisions of any law for the time being in force concerning ragging; investigate complaints and also, monitor and oversee the performance of the Anti-Ragging Squad (ARS) in prevention of ragging in the Jamia Hamdard, New Delhi.

(ii) The ARC is responsible for inculcating a culture of Ragging Free Environment on Campus.

(iii) The ARC is involved in designing strategies and action plan for curbing the menace of ragging in the departments/schools/college/centres of Jamia Hamdard by adopting an array of activities.

(iv) The ARC is also responsible for conducting awareness programmes from time-to-time on the campus.
