He sought to promote higher learning while emphasizing the rich contributions of Islam and Islamic culture to Indian civilization. Alongside this, he aimed to strengthen research and development in Unani medicine by integrating traditional wisdom with modern scientific methods to address contemporary health challenges.

Over time, Jamia Hamdard grew into a prominent institution of higher education, offering a wide range of academic programs across multiple disciplines. A major milestone in this journey was the introduction of a specialized MBA program in Healthcare and Pharmaceutical Management in 2005 under the Department of Management.
