





- You will be entitled to medical cover and Leave Travel Concession as applicable to teachers of Jamia Hamdard, from time to time.

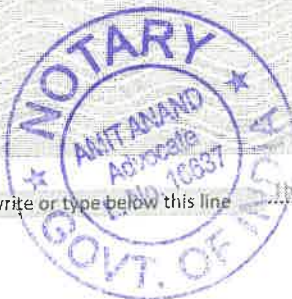
