MINUTES OF MEETING WITH THE PARENT REPRESENTATIVES OF HIMSR (2024 MBBS BATCH) HELD ON 02.01.2026 AT 3.30 P.M. IN THE CHAMBER OF THE VICE CHANCELLOR, JAMIA HAMDARD

As per the email request dated 31.12.2025 received two of the concerned parent representatives of MBBS 2024 batch, a meeting is held on 02.01.2026 and the following were present:

The following points were discussed and agreed upon:

1. **Allotment of Hostel (Boys and Girls):** VC informed the parent representatives there is no issue about allotment of hostel to MBBS 2024 Batch students subject to availability and first come first serve basis. The delirious desirous MBBS students (2024 Batch) may contact the provost (Boys and Girls) over phone Numbers

2. **Formal Meeting of the University authorities with the parents and medical Students:** In order to remove doubts and misinformation among the parents and students on various academic related issues, it was decided to have two separate meetings on hybrid mode preferably on a holiday so that the desirous parents can participate in the meeting. If required the meeting can be Live streamed through university website by the CIT, JH. A presentation will be made by the University to clarify on many academic, administrative and legal issues related to HIMSR. The format of the meeting will be addressed by the Vice Chancellor other University Officers, followed by Q&A Session.

3. **Regular update about HIMSR website (www.himsr.ac.in):**

- i. The VC informed that both the university websites created for HIMSR viz. www.himsr.org and www.himsr.co.in were illegally captured by Hamdard Education Society/Hamdard National Foundation – MREC. The first website was listed on the NMC website against HIMSR and false information about the status of HIMSR and illegal prospectus for MBBS/MD/MS Admissions for AY 2024-25 were uploaded unauthorised persons using the name of HIMSR.
- ii. The University already filed a criminal complaint(s) with the Delhi Police, IFSO, Dwarka, New Delhi and criminal complaints with the District Courts against two suspended officials of HIMSR as well as the office bearers of Hamdard Education Society including Dr. G.N. Qazi former VC of JH and former DG of HIMSR who claiming himself as CEO of HIMSR

on the website information. The Secretary, NMC was also duly informed about the illegal prospectus and hijacking digitally the University websites meant for HIMS.
iii. The official new website with ERNET domain for Hamdard Institute of Medical Sciences and Research (HIMS) is www.himsr.ac.in. The new website has been obtained from the ERNET, Govt. of India by the University after following due procedure and approvals. COE and Dean, HIMS are advised to communicate with the HIMS students through the www.himsr.ac.in (link <https://www.himsr.ac.in/notifications.php>).

4. **Accessibility of common amenities of the University by HIMS Students:** Parents representatives raised concerns about deprivation of university amenities to MBBS students of 2024 Batch. In response to the same, the VC and Registrar categorically stated there has been no such restrictions for the use of University Library, Sports Facility and other amenities in the University campus by the medical students at any point of time.

5. **Remittance of Fee Payment by MBBS and MD/MS Students:** -

- i. The parents raised their concerns about the remittance of fees due in future subsequent to the regularization of the admissions of 2024 Batch of MBBS//issue of enrolment number. From HIMS side they were citing the Prospectus 2024 MBBS conditions for making of the payment as per the schedule otherwise the students will not be allowed to attend the classes and payment of penalty.
- ii. As of now, many students from 2024 Batch of MBBS have already deposited two years fees 1st year and 2nd year with HIMS and any future payment will be arisen from 31st July 2026 as per the HIMS prospectus available on the website www.himsr.co.in

Responses from the University:

- i. Vice Chancellor and Registrar had categorically stated that strict adherence of the decision of the Executive Council, Finance Committee and Academic Council which shall be followed in letter and spirit as per the Notification dated 14.11.2025.
- ii. The VC and the Registrar also appraised the representatives that if a student fails to remit all future fees with the University operated HIMS bank A/c No. 09150405 2000 0004 in the name of Jamia Hamdard- Hamdard Institute of Medical Sciences and Research (HIMS) linked with the Jamia Hamdard PAN Number, the University shall be constrained not to allow the students to sit in the University examinations and their degrees will not be released under any circumstances as the University is bound by the resolutions/decisions taken by its highest authority body viz. Executive Council.
- iii. The Vice Chancellor also pointed out that all 2024 Batch and other HIMS students are required to follow the instructions contained in the University Admission Prospectus 2024-25 and not the illegal HIMS prospectus which has no approval by the University authorities. The new payment schedule for next academic sessions will be worked and to be circulated among the students as well through the HIMS official website.

- iv. The VC also appraised the Parent Representatives that the Comptroller and Auditor General of India audit after going through the HIMS records, observed that a large sums on accounts of the students fees and other revenues generated from the HIMS and its associated teaching hospital namely HAH Centenary Hospital of the University were diverted to illegally opened bank accounts opened and operated by a third party society namely Hamdard Education Society (HES) in gross violations of the UGC Regulations and

RBI KYC norms. Even now the C&AG audit party is already stationed here for auditing for two FY 2023-24 & 2024-25 being a government aided deemed to be University. It was also pointed out that all admission in HIMSR is done against the 'Deemed University quota' not against affiliated college category as wrongly claimed by private persons. HIMSR is integral part of the Jamia Hamdard.

- v. The VC assured the parents representatives that the University administration shall extend full cooperation with regard to their academic progression and wellbeing in the University campus and shall protect them from any threats by private parties and suspended and illegal persons who are spreading misinformation about the University and the status of the HIMSR.
- vi. Because of large scale violations of UGC Regulations, the University authority bodies resolved not to make any admissions in MBBS/MD/MS seats for current academic year 2025-26 which has been accepted by the NMC vide order dated 23.7.2025 and all the appeals against the said orders have been rejected by NMC and the Central Government. In this connection, the VC also appraised about the recent decision of the Division Bench of the Delhi High Court dated 17.12.2025 in EFA(OS) 22/2025 titled Jamia Hamdard Vs Asad Mueed & Others wherein the Hon'ble High Court has upheld the decision of the University not to make admissions in MBBS and MD/MS seats for the current academic year 2025-26.
- vii. The Division bench gives a detailed account about the powers and obligations of the Jamia Hamdard being a deemed to be university and quashed the judgement dated 8.12.2025 passed by the Single Judge. The Hon'ble Delhi High Court in the appeal EFA (OS) 22 of 2025 held that: -

Para 35.2 : The Appellant's obligation, if any, to extend support to HIMSR shall remain strictly subject to and governed by the requirement that such support be "within the confines of law", as recorded in paragraph 13 of the order dated 16.09.2025 in Arb. A. No.3/2025; nothing in this order shall be construed as compelling the Appellant to act contrary to any statutory provision, regulation, or binding direction issued by the University Grants Commission, the National Medical Commission or any other competent statutory authority.

- viii. The VC also informed the representatives that the Jamia Hamdard being a government aided deemed to be University is bound by the UGC (Institutions Deemed to be Universities) Regulations, 2023 which mandates all the students' fees are required to be deposited only with the bank accounts operated by the Institution deemed to be University/Jamia Hamdard.
- ix. Further the Jamia Hamdard cannot enter into any arrangements with private parties to run its institutions/centre/department/college or any course and it is prohibited in terms of UGC Regulations as pointed by the UGC through Public Notice by the Secretary, UGC vide F.No.6-8/2025(AMPC), dated 08.10.2025 according to which deemed to be universities are not allowed to affiliate other colleges or institutions to offer courses leading to the award of degrees, diplomas, or other academic qualifications. Any degrees or qualifications awarded through unauthorised centres or affiliated institutions are considered invalid and are not recognized for purposes of higher education or employment.
- x. Hence it is in the best interest of the parents of every student admitted in HIMSR to ensure not to create any kind of relations with a third-party society like Hamdard Education Society by remitting fees to their illegal bank accounts with PNB Asaf Ali Road New Delhi or submit any demand draft which is likely to be put for collection through such unapproved bank

accounts. Otherwise, their academic qualifications become questionable in the eyes of regulatory body and they may become ineligible for further studies and employment as per notification dated 8.10.2025. It is also made clear that the NMC through its letter dated 24.7.2025 has asked the University to regularise all the students admitted in HIMS in 2024 batch.
