Specifications and tender document downloaded from our website www.jamiahamdard.ac.in and dropped in the tender/quotation box available in the Purchase Section.
2. Prices should be quoted in India currency plus GST.
3. **Jamia Hamdard will deduct an amount of 0.25% from all the bills for "Jamia Hamdard Relief and Welfare Fund".**
4. The specifications given in Annexure-A should be strictly followed.
5. Delivery Period: Within a week.
