Sub: Regularization of admissions of existing MBBS/MD/MS Students in Hamdard Institute of Medical Sciences and Research – Decision on withdrawal of medical seats for the academic year 2025-26 – regarding

It is notified to all the students and their parents of Hamdard Institute of Medical Sciences and Research (HIMSR) of Jamia Hamdard (deemed to be University) that the National Medical Commission, UGMEB, National Medical Commission (NMC) vide order 1st cited while informing the Jamia Hamdard about the decision on withdrawal of medial seats for academic year 2025-26 of HIMSR had clarified that *this decision will not affect students who are already enrolled at HIMSR. Their admissions remain valid and must be duly regularized by Jamia Hamdard (Deemed to be University).*

2. That Appeal Committee of NMC vide para 22 of its Order 2nd cited further clarified that *the decision not to grant renewal of 150 MBBS seats to HIMSR for the academic year 2025-26 shall not affect students already admitted in previous academic sessions. Their admissions remain valid and must be duly regularized by Jamia Hamdard (Deemed to be University) in accordance with the applicable regulations. The University is accordingly directed to take all necessary steps to ensure the academic continuity of these students and to maintain regulatory compliances under the relevant provisions of the UGC and NMC Regulations.*

3. The Academic Council of Jamia Hamdard in its 49th Meeting held on 21.08.2025 (under item 49 AC (27) (a) after considering the aforesaid communications resolved to constitute a Committee under the Chairmanship of the Registrar, Jamia Hamdard to look into the matter and to make suitable recommendations to the Vice Chancellor in this regard. Accordingly, a committee was constituted by the University vide Office Order F.No.JH/RO/HIMSR/Legal-WP/2025/ICOR/30, dated 04.09.2025 to work out the modalities for regularization of existing medical students of HIMSR.

4. That the recommendations of the said Committee were placed before the 71st Meeting of the Executive Council of Jamia Hamdard held on 28.10.2025. The Executive Council after careful consideration of the recommendation of the Committee under Item No. EC: 71(19) **RESOLVED** to approve the following recommendations of the Committee:

- i. The Committee after going through the records of admissions and getting clarifications from Prof. M. Iqbal Alam recommends that the admissions of 150 MBBS students and 48 MD/MS students may be confirmed and all the students may be issued with University Enrolment numbers by the office of the Controller of the Examinations.
- ii. Every enrolled student of HIMSR appearing in the future university examinations shall produce a written undertaking (in a suitable affidavit) to the effect that all future fees (all kind) shall be deposited by them with the University operated bank A/c as per the University Circular dated 24.07.2025 as mandated by the UGC (Institutions Deemed to be Universities) Regulations, 2023, failing which the University will not be conducting the Examinations of HIMSR Medical students.
- iii. The Committee also discussed in detail about the holding of 1st Professional Examinations for 2024 Batch MBBS students by HIMSR without the same being notified by the office of the Controller of Examinations and even the students are not enrolled formally in the University. Their Answer books may be reevaluated by another set of external examinations with the due approval of the Vice Chancellor. Keeping in view of the larger interest of the students who appeared in the said Examinations held from 08.09.2025, may be regularized as a very special case in the light of the NMC directives dated 24.07.2025 and the results may be declared to avoid any litigations.
- iv. As per UGMEB NMC directives issued vide public notice No. U-14021/01/2024-UGMEB, dated 06.02.2024, every Medical College/Institutions/Deemed to be Universities were directed to furnish the Video recordings of all Annual Examinations for every phase of MBBS (1st, 2nd and 3rd- final) to be conducted by the colleges/institution/deemed to be University along with the completed Standard Assessment Form-C electronically to NMC via email ID: ug.exam@nmc.org.in immediately after the completion of the said examination. As per the requirement under the NMC guidelines, the Assessment Report for the said Examination is supposed to be submitted by the External Examiner directly to the Director, UGMEB, NMC in the standard format.
- v. In order to stop the illegal holding of University level medical examinations, the Committee recommends that the appointment of External and Internal Examiners to hold all the future professional examinations for MBBS be issued by the Controller of Examinations office directly as per the practice being followed by other deemed to be Universities. The In-charge, Examination Cell of HIMSR shall strictly enforce the order dated 01.10.2025 issued by the Office of the Controller of Examinations regarding Holding of University Examinations and Standard Operating Procedure issued on 17.03.2025.
- vi. The Examinations Branch may closely monitor the approval of examiners for all medical programmes and tighten the same to avoid such attempts by illegal persons claiming to be acting as Dean of HIMSR.
- vii. Immediate steps be taken to debit freeze of the illegal PNB bank account (s) Asaf Ali Road Branch, New Delhi which is being operated in the name of HIMSR by another third-party society namely Hamdard Education Society to stop the illegalities and violations of the UGC Institutions Deemed to be Universities Regulations. At present the student fees are diverted and siphoned off by Hamdard Education Society through the said account.

viii. *The decision of the University be informed to the National Medical Commission suitably in response to its letter dated 24.07.2025.*

5. The decision of the Executive Council (EC) of the Jamia Hamdard has been duly communicated to the National Medical Commission and the Ministry of Health & Family Welfare vide letter F.No. JH/RO/HIMSR/Legal-WP/2025/ECOR/144, dated 14.11.2024 electronically (copy enclosed). In the said letter, the NMC was informed about the decision of the EC for regularization of admissions of 150 MBBS and 48 MD/MS students' of 2024 batch subject to the conditions stipulated by the EC viz. deposit of all kind of fees with the University operated bank account for HIMSR and production of written undertaking from each student of HIMSR.

6. That the EC in the same meeting also considered the contents of the UGC Public Notice issued by the Secretary, UGC vide F.No.6-8/2025 (AMPC), dated 8th October 2025 (copy enclosed) wherein the UGC categorically stated that *private universities and deemed to be universities are not allowed to affiliate other colleges and institutions to offer courses leading to the award of degrees, diplomas or other academic qualifications. Any degrees or qualifications awarded through unauthorised centres or affiliated institutions are considered invalid and are not recognized for purposes of higher education or employment.* Therefore, keeping in view of the larger interest of the medical students enrolled in HIMSR, the EC under a separate Item No. 71(2)) **further RESOLVED** that no further admissions in HIMSR be permitted unless and until all statutory compliances under UGC (Institutions Deemed to be Universities) Regulations and NMC Regulations are adhered to by HIMSR and to be ensured by the University.

7. In the light of UGC (Institutions Deemed to be Universities) Regulations 2023 and the stringent directives issued by the UGC to private and deemed to be Universities by the Secretary UGC vide Public Notice dated 08.10.2025, through this Notification all the students of HIMSR in their own interest, are hereby directed to furnish a written undertaking in the prescribed format attached to this Notification in compliance with the decision of the Executive Council of Jamia Hamdard failing, all such defaulting students shall be barred from taking any future University Examinations and they will not be entitled to receive their degrees. No deviation shall be allowed under any circumstances.

NOTICE

Sub: Clarification about Fee Submission of HIMSR Students (MBBS/ MD/MS/M.Sc-Medical/Ph.D scholars) enrolled in Jamia Hamdard (Deemed to be University)

The Jamia Hamdard administration is receiving several queries through email and other channels regarding clarity about submissions of tuition, examination and other fees as well as conduct of university examinations in respect of medical students (MBBS, MD/MS/M.Sc-Medical/Ph.D courses) enrolled in Jamia Hamdard.

2. In this regard, it is notified to all enrolled students of HIMSR and their parents that: -

A. Remittance of Students Fees:

- i. As per the statutory requirements under the UGC (Institutions Deemed to be Universities) Regulations, 2023 which is binding on Jamia Hamdard (being a deemed to be University) all kind of tuition and other fees of every enrolled student of Jamia Hamdard in different schools/departments/centers including Hamdard Institute of Medical Sciences and Research (HIMSR) are to be deposited only in the University operated bank accounts.
- ii. For the medical students of HIMSR, a separate bank account No. 0915040520000004 in favour of Jamia Hamdard, Hamdard Institute of Medical Sciences & Research (HIMSR), IFSC Code: JAKA0JAMIAH, linked with Jamia Hamdard PAN No. AAATJ2432R with the Jammu and Kashmir Bank Branch, Jamia Hamdard Campus, New Delhi-110062 as per the regulatory requirements has been opened and being operational.
- iii. All the existing medical students are, therefore, once again **advised to deposit all their fees ONLY with the above official bank account of Jamia Hamdard in their own interest failing which the Jamia Hamdard administration will not be responsible for any lapse on the part of the students in this matter.**
- iv. The Bank A/c No. 0127002100093391 in the name of Hamdard Institute of Medical Sciences and Research (HIMSR) with Punjab National Bank (PNB) Branch, Asaf Ali Road, New Delhi (MICR Code 110024038 Swift Code PUNBINBBISB SOL number 012700) is an unauthorised account and opened by a third-party society namely Hamdard Education Society (HES) with its PAN or any other account. Besides, the C&AG Audit team also objected to the same in its report dated 02.05.2025 Therefore, all medical students are advised to be cautious about the same while remitting their fees. Jamia Hamdard will not be responsible for any wrong remittance to such unauthorised bank account.

B. Holding of University Examinations for MBBS/MD/MS/M.Sc/Ph.D course work

- i. All University Examinations of MBBS students viz. First Professional, Second Professional and Third Professional as per the requirements of MBBS byelaws of HIMSR Students and Revised Competency Based Medical Education Curriculum (CBME) Guidelines, 2024 - National Medical Commission circulated vide No.D-11011/500/2024/AC New Delhi, dated the 12th Sept 2024 as well as MD/MS shall be held by Jamia Hamdard (Deemed to be University) only as per the Date Sheet and/or notification issued under the signatures of the Office of the Controller of Examinations and not at the School/HIMSR level.

- ii. As per the Examinations Rules and in terms of UGC Institutions Deemed to be Universities Regulations, 2023 no other officer or officials are authorized to hold any University Examinations for the regular students including the medical students of HIMSR. All students and teachers are hereby advised not to take cognizance of such illegal and unauthorized examinations or date sheet or notices other than the office of the Controller of Exams of Jamia Hamdard.
- iii. That the Teacher In-charge of the Examination Cell of HIMSR, Jamia Hamdard is hereby directed to take note of the above in the larger academic interest of the students. All such examination related papers of HIMSR shall only be routed through the legally appointed Principal/Dean, HIMSR i.e. Prof. Sudhir Kumar Jain. He is functioning from Room No.107-A of First Floor of the Administrative Block, Science Building, Jamia Hamdard. He is available for any assistance and redressal of student grievance. He can be contacted at Mob. 8076806485 email: deanhimsr@jamiahamdard.ac.in.
- iv. With regard to signing of documents etc. by Prof Musharraf Hussain (under suspension) claiming to be the Dean of HIMSR such documents cannot be accepted by Jamia Hamdard in the larger interests of students. Jamia Hamdard cannot in the interests of students accept such illegal and void documents as it will ultimately harm the career of the students.

C. Decision of the National Medical Commission:

- i. The NMC after taking into cognizance of the large-scale statutory violations in admission, examinations, illegal bank accounts by third parties and unauthorized persons at HIMSR, in the broader interest of the academic and career prospects of the students has decided that no renewal be granted to HIMSR for 150 MBBS seats for the academic year 2025-26.
 - ii. **The NMC in its recent communication dated 24.07.2025 also clarified to the Jamia Hamdard that this decision will not affect the students who are already enrolled at HIMSR and their admission remain valid and must be duly regularized by the Jamia Hamdard (Deemed to be University). Modalities will be worked out soon by the Jamia Hamdard in consultation with the NMC with the approval of the competent bodies of Jamia Hamdard in compliance with the UGC Regulations.**
3. It is also to notify to all students concerned that the Jamia Hamdard is a Deemed to be University and is bound to comply with the directions issued by the UGC and NMC and is committed to safeguard the interests of all enrolled medical students in Jamia Hamdard. Jamia Hamdard seeks the cooperation of the students and teachers of HIMSR in this regard.

Subject: Decision on Withdrawal of Medical Seats for Academic Year 2025-26 - Hamdard Institute of Medical Sciences and Research (HIMSR)

Sir,

In reference to the communications dated 06.06.2025; 11.07.2025 received from your university seeking request for the withdrawal of 150 MBBS seats and 49 seats in MD/MS programmes at Hamdard Institute of Medical Sciences and Research (HIMSR) for the academic year 2025-26 on the grounds of alleged irregularities and unauthorized use of the institution's name by individuals not associated with Jamia Hamdard, and not appointed as Principal/Dean of HIMSR by the competent authority, as per the UGC (Institutions Deemed to be Universities) Regulations. The aforesaid request was subsequently confirmed by your University through a formal communication withdrawing the earlier letters of consent granted to HIMSR for conducting MBBS and MD/MS programmes for the academic year 2025-26.

2. In light of the aforesaid facts and the relevant provisions of UGC (Institutions Deemed to be Universities) Regulations, 2023, the National Medical Commission considered the matter in its Coordination Meeting held on 22.07.2025 wherein the broader interest of the academic and career prospects of the students were considered and the Commission decided that no renewal be granted to HIMSR for 150 MBBS seats for the academic year 2025-26. Please note that this decision

pertains solely to admissions for the academic year 2025-26. The matter may be reconsidered for future academic sessions, subject to the outcome of the pending court cases being filed by the Jamia Hamdard (deemed to be) University or HIMSR or any other connected parties in relation to the ongoing dispute, before Hon'ble High Court of Delhi or before any other court of law.

3. Furthermore, it is clarified that this decision will not affect students who are already enrolled at HIMSR. Their admissions remain valid and must be duly regularized by Jamia Hamdard (Deemed to be University).

It is hereby brought to the attention of students, parents, and the general public that, as per the provisions of the University Grants Commission (UGC) Act, 1956, degrees can only be awarded by universities established under a Central Act, State Act, or Provincial Act, or by institutions that are deemed to be universities under Section 3 of the UGC Act, 1956, and are empowered to confer degrees.

As per the provisions of the University Grants Commission (UGC) (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003, private universities in India are not permitted to establish off-campus centres, study centres, or extension centres—even within the same state—without prior approval from the UGC. These universities are authorized to operate only from their main campus unless explicit permission is granted for additional centres. Furthermore, private universities and deemed-to-be universities are not allowed to affiliate other colleges or institutions to offer courses leading to the award of degrees, diplomas, or other academic qualifications. Any degrees or qualifications awarded through unauthorized centres or affiliated institutions are considered invalid and are not recognized for purposes of higher education or employment.

However, it has come to the notice of the UGC that an entity operating under the name "Emversity," located at 082, Shobha Millennium, 12th Main Road, HAL 2nd Stage, Appareddipalya, Indiranagar, Bangalore, along with its affiliated centres, is offering degree programmes through franchising, collaboration, or agreements with private universities and deemed-to-be universities.

Such practices are strictly against the provisions of the UGC Act, which prohibits universities from offering degree programmes through franchising arrangements. The UGC warns students and parents to verify the recognition and legal status of any institution before enrolling. Obtaining degrees from unauthorized or unrecognized institutions may result in such qualifications being considered invalid. Therefore, for accessing the list of recognized universities and approved institutions, the stakeholders are advised to visit the official UGC website at www.ugc.gov.in and check the HEIs section.

एतद् द्वारा छात्रों, अभिभावकों और आम जनता के संज्ञान में यह बात लाई जाती है कि विश्वविद्यालय अनुदान आयोग (यूजीसी) अधिनियम, 1956 के प्रावधानों के अनुसार, डिग्रियाँ केवल उन्हीं विश्वविद्यालयों द्वारा प्रदान की जा सकती हैं जो किसी केंद्रीय अधिनियम, राज्य अधिनियम या प्रांतीय अधिनियम के तहत स्थापित किए गए हैं, या उन संस्थानों द्वारा जिन्हें यूजीसी अधिनियम, 1956 की धारा 3 के तहत मानित विश्वविद्यालय (डीम्ड-टू-बी यूनिवर्सिटी) का दर्जा प्राप्त है और जिन्हें डिग्रियाँ प्रदान करने का अधिकार प्राप्त है।

विश्वविद्यालय अनुदान आयोग (यूजीसी) (निजी विश्वविद्यालयों में मानकों की स्थापना और मानकों के अनुरक्षण) विनियम, 2003 के प्रावधानों के अनुसार, भारत में निजी विश्वविद्यालयों को यूजीसी की पूर्व अनुमति के बिना ऑफ-कैंपस केंद्र, अध्ययन केंद्र, या विस्तार केंद्र यहाँ तक कि उसी राज्य के भीतर भी स्थापित करने की अनुमति नहीं है। इन विश्वविद्यालयों को केवल अपने मुख्य परिसर से ही कार्य करने की अनुमति होती है, जब तक कि उन्हें अतिरिक्त केंद्रों के लिए स्पष्ट अनुमति प्राप्त न हो। इसके अतिरिक्त, निजी विश्वविद्यालयों और मानित विश्वविद्यालयों (डीम्ड-टू-बी विश्वविद्यालयों) को अन्य कॉलेजों या संस्थानों को इस प्रकार से संबद्ध (Affiliate) करने की अनुमति नहीं है कि वे डिग्री, डिप्लोमा या अन्य शैक्षणिक योग्यता प्रदान करने वाले पाठ्यक्रम चला सकें। ऐसे किसी भी अनधिकृत केंद्रों या संबद्ध संस्थानों के माध्यम से प्रदान की गई डिग्रियाँ या योग्ताएँ अवैध मानी जाती हैं और उन्हें उच्च शिक्षा या रोजगार के उद्देश्यों के लिए मान्यता प्राप्त नहीं होती।

हालाँकि, यूजीसी के संज्ञान में यह बात आई है कि "एमवर्सिटी" नाम से संचालित एक संस्थान, जिसका पता है- 082, शोभा मिलेनियम, 12वीं मेन रोड, एचएएल द्वितीय स्टेज, अप्पारेडिपाल्या, इंदिरानगर, बेंगलुरु में स्थित है, यह अपने संबद्ध केंद्रों के साथ मिलकर निजी विश्वविद्यालयों और मानित विश्वविद्यालयों (डीम्ड-टू-बी विश्वविद्यालयों) के साथ फ्रैंचाइजिंग, सहयोग या समझौतों के माध्यम से डिग्री कार्यक्रमों को संचालित कर रही है।

इस प्रकार की परिपाटी यूजीसी अधिनियम के प्रावधानों के सख्त विरुद्ध हैं, जो विश्वविद्यालयों को फ्रैंचाइजिंग व्यवस्था के माध्यम से डिग्री कार्यक्रम संचालित करने से प्रतिबंधित करता है। यूजीसी छात्रों और अभिभावकों को चेतावनी/सलाह देता है कि किसी भी संस्था में प्रवेश लेने से पहले उसकी मान्यता और कानूनी स्थिति की सत्यापन/पुष्टि अवश्य करें। अमान्यता प्राप्त या अस्वीकृत संस्थानों से प्राप्त की गई डिग्रियाँ अमान्य मानी जा सकती हैं।

इसलिए, मान्यता प्राप्त विश्वविद्यालयों और अनुमोदित संस्थानों की सूची तक पहुंचने के लिए, हितधारकों को सलाह दी जाती है कि वे आधिकारिक यूजीसी वेबसाइट www.ugc.gov.in पर जाएं और HEI सेक्सन की जांच करें।
