PUBLIC NOTICE

It is notified to all stake holders of Jamia Hamdard including Hamdard Institute of Medical Sciences and Research (HIMSR) and its attached teaching hospital namely Hakeem Abdul Hameed Centenary Hospital (HAHCH) that:

- i. The Academic Council (AC) and Executive Council (EC) of the Jamia Hamdard in its Meeting held on 24.02.2025 and 27.02.2025 (respectively) resolved not to offer MBBS/MD/MS/M.Sc Medical programmes in Hamdard Institute of Medical Sciences & Research (HIMSR) for the academic year 2025-26, in view of the large scale violations of UGC Institutions Deemed to be Universities Regulations, 2023 by third parties and unauthorised persons in admissions, illegal students' fee collection through cloned bank accounts opened in the name of HIMSR and HAHCH linking with the PAN of a third party society namely Hamdard Education Society (HES), illegal GST number, TAN number etc.
- ii. The decision of the AC and EC was communicated to the National Medical Commission by the Jamia Hamdard vide a letter dated 06.06.2025, followed by two letters on 11.07.2025 & 22.07.2025 wherein the consent for affiliation for 150 seats of MBBS and 49 seats of MD/MS courses in HIMSR were withdrawn and the same was duly communicated to the NMC and Medical Counselling Committee (MCC).
- iii. The NMC through an order No. Renewal/UGMEB/2023-24/328, dated 23.07.2025 from the Director, UGMBE addressed to the Dean, HIMSR, Jamia Hamdard in which it was informed that National Medical Commission, after considering the communications received from the University regarding the alleged irregularities and misuse of name of its constituent institution namely HIMSR by the unauthorized persons not connected to the affairs of Jamia Hamdard and persons not appointed as Principal/Dean of the HIMSR and further regarding the withdrawal of all earlier letters of consent for running MBBS and MS/MD programs at HIMSR for the academic year 2025-26 and pursuant to a decisions made in the NMC meeting dated 22.07.2025, the Under Graduate Medical Education Board has decided not to grant renewal of 150 UG (MBBS) seats to HIMSR for the academic year 2025-26, in order to safeguard the academic and career prospects of the students.



- iv. The NMC through a subsequent communication Renewal/UGMEB/2023-24/328, dated 24.07.2025 from the Director, UGMBE addressed the Registrar, Jamia Hamdard it was informed that in light of the aforesaid facts and the relevant provisions of UGC (Institutions Deemed to be Universities) Regulations, 2023, the National Medical Commission considered the matter in its Coordination Meeting held on 22.07.2025 wherein the broader interest of the academic and career prospects of the students were considered and the Commission decided that no renewal be granted to HIMSR for 150 MBBS seats for the academic year 2025-26. Please note that this decision pertains solely to admissions for the academic year 2025-26.
- v. The NMC in its aforesaid communication also stated that the matter may be reconsidered for future academic sessions, subject to the outcome of the pending court cases being filed by the Jamia Hamdard (deemed to be) University or HIMSR or any other connected parties in relation to the ongoing dispute, before Hon'ble High Court of Delhi or before any other court of law. Furthermore, it is clarified that this decision will not affect students who are already enrolled at HIMSR. Their admissions remain valid and must be duly regularized by Jamia Hamdard (Deemed to be University).
- vi. That the above two communications by NMC and letter dated 22.7.2025 of Jamia Hamdard were filed by the NMC on 24.07.2025 before the Hon'ble High Court of Delhi in W.P(C) No.6511 of 2025 filed by the Jamia Hamdard against Union of India, NMC, MCC and UGC (presently pending for adjudication before the Single Judge). Copy enclosed for information.
- vii. That on the same day i.e. 24.07.2025, the Jamia Hamdard had issued a clarification Notice F.No. JH/RO/HIMSR/2025/ICOR/24, dated 24.07.2025 to all students of HIMSR about the Fee submission of HIMSR students, holding of university examinations for MBBS/MS/MD/M.Sc-Medical/Ph.D programmes and the decision of the NMC for not granting HIMSR for 150 MBBS seats for the academic year 2025-26. In the said notice, all the students of HIMSR were asked to deposit their fees with only the University operated bank a/c with the J&K Bank and specifically not to deposit with the illegal PNB A/c No being operated by third party namely Hamdard Education Society with PNB, Asaf Ali Road, New Delhi or any other bank account.
- viii. That concerns were raised by some of the students about the deposit of student fees in other accounts under coercion by interested parties on 27.07.2025 and a suitable response to them in this regard. It is hereby reiterated that all the Bonafide students of HIMSR including MBBS/MD/MS Batch of 2024 are once again asked not to pay heed to any such requests for the fee deposit under any circumstances. Jamia Hamdard administration is committed to protect the interest of students who are already enrolled at HIMSR, Jamia Hamdard as per the decision of the NMC (as per para 3 of NMC letter dated 24.7.2025).
 - ix. Meanwhile, it has been brought to the notice of the Jamia Hamdard administration that misinformation has been spread through an advertorial appeared in the Hindustan Times on Sunday, July 27, 2025 at page-5 on behalf

- of Hamdard Education Society in the form of rebuttal to a prominent news item appeared in the Times of India, Delhi Editon on July 22, 2025 (page No.5).
- x. That in the larger interest of the students and stakeholders of Hamdard Institute of Medical Sciences and Research (HIMSR), Jamia Hamdard pointwise response on the said rebuttal by Hamdard Education Society from the Jamia Hamdard administration is attached for the better understanding and giving the true legal position in this case.

Response by Jamia Hamdard to the Rebuttal by Hamdard Education Society, a registered society with Regd. No.S-11517 of 1981 with registered office at Talimabad, Sangam Vihar, New Delhi 110080, appeared in the Hindustan Times on July 27, 2025 (page 5) to the Times of India news item appeared on 23.7.2025

Misrepresentation regarding withdrawal of MBBS and PG Seats	Response
a. Unilateral withdrawal of affiliation by Jamia Hamdard vide communication dt. 6.6.2025.	 Jamia Hamdard is a unitary deemed to be University with no powers to grant affiliation to institutions under other societies. In the past HES in July 2024 had made an attempt unilaterally to obtain autonomous status for HIMSR bypassing the Jamia Hamdard but the same was rejected by the UGC vide letter dated 9.7.2024. HES is wrongly claiming that HIMSR stand transferred to HES from Jamia Hamdard without any valid document. University land is in the name of Jamia Hamdard and as per DDA perpetual lease deed conditions, it is a government land the same cannot be transferred or assigned or sub-leased to any third party without the due approval of the Lt. Governor of Delhi/DDA. The land and buildings of HIMSR and its hospital belong to the Jamia Hamdard and no members of the third party can lay claim on it. It is a criminal act by HES and HNF-MREC. The decision of the JH to withdraw the consent for award of degrees to the students of HIMSR was taken after due deliberations by its academic and executive bodies. The primary reasons for withdrawal were clearly outlined in the letter dated 6.6.2025 sent to the NMC and the major violations were violations of UGC Institutions Deemed to be Universities Regulations, diversion of huge funds to third party bank accounts and not providing 85% seats in MBBS to Delhi Domicile candidates as per the Essentiality Certificate issued by the Delhi Govt.
b. Status quo of HIMSR Delhi High court order dt 20.9.2022	 It is denied that there are any violations of status quo order passed by the Delhi High court. The petition was filed by two private parties Mr. Abdul Majeed and his brother Mr. Asad Mueed and not by the Hamdard Education Society. As per the order, the JH is expected to facilitate the Family settlement to the extent if the terms and conditions are legal, as per law and as per the UGC Institutions Deemed to be Universities Regulations, 2019 (as per the earlier order dated 27.5.2019). On 7.11.2022 UGC directed the JH that assets of JH cannot be bifurcated and income of the JH cannot be

diverted to third party society accounts including the sponsoring body. Delhi High Court order did not permit HES to open illegal bank accounts against the UGC Regulations and collect student fees and empowered to do illegal acts against the law and RBI KYC norms for opening of bank accounts in the name of a medical college belong to Jamia Hamdard. Quarterly bank accounts of HIMSR as directed by the Hon'ble High Court were not submitted by the Dean, HIMSR to the University as per the court order dated 20.09.2022. No communication NMC has been duly appraised by JH about the illegal from NMC or MCC diversion of student fees through cloned bank accounts to HIMSR about opened by HES by JH. financial matters Three illegal and cloned bank accounts with J&K bank have been debit freezed from 3.1.2024. Two bank accounts with UCO Bank have been debit freezed from 9.10.2024 and two more bank accounts with PNB from 12.10.2024 on the basis of order dated 10.10.2025 by RBI Ombudsman. NMC vide its show cause notice to HIMSR. Jamia Hamdard dated 23.7.2025 has mentioned about the financial irregularities committed by third parties in the affairs of the HIMSR. In view of the larger scale violations of UGC Regulations, the NMC has decided not to grant renewal of 150 UG MBBS seats to HIMSR for the academic year 2025-26 in order to safeguard the academic and career prospects of the students. The sole grounds for not permitting the 150 MBBS seats by NMC is attributable to the financial bungling by HES. It is the HES office bearers to be blamed for undue interference with the internal functioning of the institutions of Jamia Hamdard without any legal authority. 2. - 810.49 crore, including student fees and other receipts was deposited into the new accounts of HIMSR linked with the HES PAN number.
- The Audit did not include the illegal fee collection made by HES through the cloned bank accounts from 01.04.2024 to July 2025. The total illegal fee and other income collected by HES is over Rs.1000.00 crore as on date. It is continuous and recurring in nature.
- The Ministry of Education, Govt. of India through its letter dated 15.1.2025 clarified its the position that the Sponsoring body of the JH shall be the JH Society since 1989 and there is no change. Two private parties challenged the decision of the Ministry of Education, Government of India dated 5.1.2025 before the Delhi High Court (CWP No.5477 of 2025) but the same has not been set aside till date.
- HES cannot have any say in the governance of the Jamia Hamdard or its institutions and no legal rights are accrued in its favour.
- Separate bank accounts.
- All accounts are audited by statutory auditors.
- The allegations of financial misconduct is without any merit and reckless defamation.
- HES claimed that their accounts were audited by statutory auditors (CA Firm) and how could seven separate bank accounts opened and operated by HES for HIMSR were debit freezed by J&K Bank, UCO Bank and PNB for want of RBI KYC compliance from Jan 2024 to October 2025.
- The Auditor who audited the accounts of HIMSR failed to appreciate the legal provisions under which an institution of a deemed to be University is being operated and they failed to appreciate the statutory provisions governing the maintenance of accounts by HIMSR under I.T. Act and UGC Regulations.
- JH has already registered a complaint against the misdeeds committed by the HES in this regard.
- There was a diversion of over Rs.50 crore from HIMSR (Student Fee bank accounts) from UCO Bank (now freezed) to Hamdard Education Society in two months July to August 2024 alone. If HES is a donor why such large sum is transferred back to its own accounts.
- HIMSR is not having an independent legal status. It is not a society or Trust or company. It has been created through a resolution passed by the Executive Council of Jamia Hamdard in the year 2010.
- HIMSR which is an institution attached to a deemed to be University cannot be transferred to a third-party society without the prior consent of the Government, UGC, DDA, Delhi government and National Medical Commission. Further there is no provision of transfer of the assets of the Jamia Hamdard to third parties and it is impermissible under the UGC Regulations and as per the directions of UGC dated 07.11.2022.
- Illegal obtaining of TAN and GST based on a forged NOC purportedly issued in the letter head of Jamia Hamdard – FIR No. 0406 dated 21.12.2024 with PS I.P. Estate has been registered against the HES

They are providing a minuscule aid to JH but they cannot be owners of JH. JH cannot act as affiliating University as per the UGC Regulations, 2023. HIMSR is not a registered society or Trust or Company which can seek affiliation. Delhi University and IP University are the affiliating universities in Delhi and no other University can provide affiliation to any institution in Delhi. NMC has accepted the stand taken by the Jamia Hamdard and UGC letter dated 9.7.2024 reiterated the same. Family Settlement Deed conditions should be amenable to the law and UGC Regulations as applicable to deemed to be Universities. After the objections by UGC about the FSD regarding bifurcation of assets of JH, vide letter dated 7.11.2022 the JH was compelled to adopt the dicta by the UGC. The UGC directives were adopted by the Board of Management (now known as EC) in its emergent meeting held on 05.12.2022. The said decision was challenged by two private persons namely Mr. Abdul Majeed and Mr. Asad Mueed through a OMP (I) No. 14 of 2022 before the DHC on the grounds such decision will be against the earlier decision of BOM dated 3.7.2021. The matter regarding the major violations of UGC Regulations in the admission, illegal fee collection through cloned bank accounts opened by HES was reported to the Executive Council and Academic Council and with the approval of the EC/AC of JH it was decided not to offer admission in medical courses in HIMSR in the year 2025.

	 There is no written agreement entered between JH with HNF or HES or any other party. No agreement could be entered against the UGC Regulations or against law. Transfer of land of Jamia Hamdard requires the prior approval by Govt. of India, UGC, DDA. Transfer of medical college requires the approval of NMC. It is impermissible under the law. FSD conditions entered between private parties should be legal and cannot overlook the provisions of UGC. Regulations with regard to JH and its running of the HIMSR and HAHCH.
Freezing of hospital bank accounts impacting critical healthcare	 Freezing of all bank accounts were done by the Banks on the grounds of non-compliance of RBI KYC norms and after due show cause notices to HES. All these illegal and cloned bank accounts are lacking KYC and no PAN number is available in the name of HIMSR or its Hospital. The Income Tax authorities were already seized of the matter and the violations by HES in such illegal bank accounts. In the name of providing critical healthcare, bank accounts were used for illegal fee collection from HIMSR students.
Dissemination of false narration by JH.	 Private parties on the one side claims it is under the control of HNF (Medical Relief and Education Committee) and on the other hand it had illegally diverting money to HES. Illegal NMC and MCC portal control does not grant any legal authority to private parties or societies of a medical college- HIMSR. False narration has been created by the office bearers of HES and Medical Relief and Education Committee of Hamdard National Foundation.
Hinderance of day- to-day academic functioning of HIMSR	 Members of HES has no business to interfere with the day to day functioning of an academic institution like HIMSR nor it has any legal right to do so. HES office bearers have been portraying themselves as promoter members or owners of the Medical college belonging to Jamia Hamdard wrongly. UGC Regulations does not permit any interference by third party or private members or donors in the day-to-day academic functioning. Both HNF and HES are charitable societies and tax exemptions are not granted to receive the student fees from HIMSR. Jamia Hamdard has already made a complaint with the Income Tax Authorities. HES office bearers are making illegal appointment of teachers and other staff in HIMSR, Jamia Hamdard without any approval or knowledge of Jamia Hamdard (Deemed to be University).
5. Reaffirmation of Legal and institutional compliance by HES	 A medical College set up by the Jamia Hamdard which is a government aided deemed to be University cannot cater the private needs.



- HES office bearers tried to usurp the powers of the Jamia Hamdard without any legal authority with ulterior motives.
- HIMSR was created by way of resolution passed by JH and not by HNF or HES. Application for the medical college is made by JH.
- Essentiality certificate for starting new medical college is in the name of JH.
- Approval letter for the medical college is in the name of Jamia Hamdard.
- As per the observation of the C&AG audit, through manipulation HIMSR has been wrongly shown as constituent institution under the control of HNF.
- UGC Regulations prohibits the deemed to be Universities from entering into such arrangement with a third party to run a course or a college or an institution.
- HES is not a stakeholder for consultation by the Jamia Hamdard in an internal matter. HES should have stopped the auditors from C&AG office during the audit process (Jan to April 2025) if auditing of HIMSR is not as per law.
- HES has been barred to show HIMSR and HAHCH as its own institutions in the MOA by the Registrar of Societies-South in his order dated 25.2.2025. HES challenged the said order before Delhi High Court in CWP No.3510 of 2025. Order dated 25.2.2025has not been set aside till date by the Delhi High Court. Illegal amendment in MOA of HES was carried out stealthily on 3.9.2024 by filing false affidavits to meet RBI KYC norms.
- The following are the major statutory violations committed by HES in relations to the functioning of HIMSR: -
- a. Illegal bank accounts in the name the medical college without RBI KYC Compliance
- b. Illegal GST registration (FIR is registered)- charge sheet is being filed by the Delhi Police against HES
- c. Illegal TAN registration linking the PAN of HES.
- d. Illegal diversion of money siphoning off students funds to HES accounts.
- e. Misuse of medical college website by HNF and HES.
- f. 85% Delhi Domicile quota has been consistently violated in MBBS admissions in HIMSR.
- g. If HIMSR is coming under the control of HNF or HES and then how come HIMSR is considered as a Minority institution.
- h. Either HNF or HES has been declared as Minority Institution by the National Commission for Minority Educational Institution Act. Minority status granted to JH has been misused in this case.
- High Tuition fees for HIMSR medical courses are fixed without the approval of JH or Delhi Govt.

ORDER

WHEREAS vide Public Notice dated 01.11.2024 issued by UGMEB on the website of NMC on 06.11.2024, directing all medical colleges with valid Letters of Permission (LoP) to upload the details/data of their respective institutions on the NMC portal for the annual declaration, as required under the NMC Act, 2019 and various regulations issued by NMC from time to time, for the grant of renewal of MBBS seats for the academic year 2025-26.

WHEREAS based on the details furnished by your college, the experts assessed the submissions, and accordingly, a Notice dated 11.05.2025 was issued highlighting the following deficiencies observed during the assessment:

- a. Twelve (12) out of Twenty (20) departments are deficient in faculty/Resident/tutor as per AEBAS record data.
- b. Inadequate Cytopathology Investigation.
- c. Birth/Death data does not co-relate with clinical load in the institute.
- d. Salary proof not attached in faculty declaration forms.
- e. Data not provided for Minor/Major OTs.

WHEREAS pursuant to above mentioned deficiencies, a compliance report were submitted by your Institution which was evaluated by the Assessors; however, amongst other deficiencies, following key deficiencies were again highlighted with respect to your College/Institution.

Cytopathology Investigation still inadequate.

WHEREAS it was further observed that during the renewal process for the previous academic year 2024-25, in view of the substantive nature of the deficiencies in your college, a conditional renewal was granted to your college and a penalty of of Rs. 6,00,000/- was imposed.

WHEREAS the Competent Authority has reviewed the Annual Declaration Report (ADR) submitted by your college/institutions and also the deficiencies pointed out by the experts. The compliance report submitted by the college has not been found to be convincing and satisfactory.

WHEREAS meanwhile the deliberations on grant of renewal were under process, the Commission received a letter no. F.No. JH/RO/HIMSR/UG-admissions/2025-26/ECOR/74 dated 06.06.2025 from the Registrar of Jamia Hamdard (Deemed to be) University, citing the irregularities and misuse of institutional name by the unauthorized persons not connected to the affairs of Jamia Hamdard and persons not appointed as Principal/ Dean of the Hamdard Institute of Medical Sciences and Research (HIMSR), the competent authority of the University in compliance with the UGC Institutional Deemed to be Universities Regulations as amended from time to time, In furtherance of allegations made by the Jamia Hamdard, the university vide abovementioned letter made a formal request for withdrawal of MBBS (150) seats), MD/MS 49 seats in HIMSR for the academic session 2025-26 wherein University has stated that a stage has been reached where it may not be possible for the Jamia Hamdard to offer the MBBS and MD/MS programmes for the new academic year 2025-26.

WHEREAS Jamia Hamdard (Deemed to be) University, in support of the above contentions, has provided the minutes of the 70th Executive Council meeting held on 27.02.2025 wherein the Executive Council resolved to adopt the recommendations of the Academic Council's 48th meeting (emergent) of the Academic Council of Jamia Hamdard held on 24th February, 2025, wherein the competent authority has decided as under:

"The Registrar appraised the members that as per the requirements under the UGC Regulations, 2023, every deemed to be University shall make available the prospectus on its website at least sixty days before the commencement of admissions, including fee structure, refund policy, number of seats in a programme, eligibility qualifications, admission process, etc. The Registrar also informed the Members that admissions related to MBBS/MD/MS/M.Sc (Medical) programmes under HIMSR are not included in the Admission Prospectus because there was a large scale violations at the hands of the unauthorized persons acting as Offg Dean/Principal. Due to which the University Administration has decided not to recognize such illegal admissions made by HIMSR by using an illegal prospectus for HIMSR. The Registrar also appraised the Members that illegal fee collections were made by HIMSR through unrecognized UCO Bank Account opened by a third party in the name of HIMSR which has been debit freezed with the orders of RBI Ombudsman order dated 15.10.2024. Notwithstanding above illegal admissions were made in MD/MS programmes even after the debit freezing of bank account and fees were collected through demand drafts from the students in the name of HIMSR. These demand drafts were encashed through another illegal bank account with PNB AsafAli Road Branch. New Delhi which was opened on 12.11.2024

...Members suggested that unless and until the matter is resolved properly, it is not advisable for the University to include Medical Programmes under HIMSR in the Jamia Hamdard Admission Prospectus 2025-26 to stop further violations of UGC Regulations, 2023 in medical admissions and keeping in the interest of the student. If required the NMC may be informed once again. The AC after due deliberations resolved to adopt the above suggestions by majority members."

WHEREAS on receipt of above communications from the University, the Commission sought further clarifications from Jamia Hamdard (Deemed to be) University as well as from your institution regarding the withdrawal of the consent of affiliation to HIMSR. To said query, the University vide letter no. F. No. JH/RO/HIMSR/Legal-WP/2025/ECOR/92 dated 11.07.2025 has acknowledged the withdrawal of all previously issued letters of consent for offering MBBS and MD/MS programmes at HIMSR for the upcoming academic year 2025–26. The University has further clarified that the Jamia Hamdard (Deemed to be) University being established under section 3 of the UGC Act, 1956 has no power to grant affiliation to other institutions and therefore it cannot be an affiliating university as per clause 26 of the UGC Institutions Deemed to be Universities Regulations, 2023. Consequently, HIMSR cannot be treated as an affiliated institution of Jamia Hamdard and it is a constituent of the Jamia Hamdard.

WHEREAS the Commission also received the reply from your institution on the same date. In your reply, a conflicting clarification was furnished wherein your college intimated that HIMSR has been under the academic, financial and administrative control of the sponsoring society namely HNF-Medical Relief and Education Committee registered under Registrar of Societies (RoS) and the only relationship HIMSR has with the University is with respect to the award of degrees to the students who pass the requisite examinations conducted by HIMSR.

WHEREAS a meeting was held in the National Medical Commission on 22.07.2025 wherein the communications received from the university regarding the alleged illegal activities being carried out by the HIMSR as well the request of the Jamia Hamdard intimating withdrawal of all earlier letters of consent for running MBBS and MS/MD programs at HIMSR for the academic year 2025–26, has been considered by the Commission in said meeting.

THEREFORE the National Medical Commission, after considering the communications received from the University regarding the alleged irregularities and misuse of name of its constituent institution namely HIMSR by the unauthorized persons not connected to the affairs of Jamia Hamdard and persons not appointed as Principal/ Dean of the HIMSR and further regarding the withdrawal of all earlier letters of consent for running MBBS and MS/MD programs at HIMSR for the academic year 2025–26 and pursuant to a decisions made in the NMC meeting dated 22.07.2025, the Under Graduate Medical Education Board,

has decided <u>not to grant renewal of 150 UG (MBBS) seats to HIMSR for the academic year 2025–26</u>, in order to safeguard the academic and career prospects of the students.

If the college / Institution is not satisfied and aggrieved with the decision of the Board, you may prefer an appeal before the Commission under Section 9, Chapter IV of the Maintenance of Standards of Medical Education Regulations 2023 (MSMER 2023) within Sixty (60) days of the issue of this letter.

Subject: Decision on Withdrawal of Medical Seats for Academic Year 2025-26 - Hamdard Institute of Medical Sciences and Research (HIMSR)

Sir,

In reference to the communications dated 06.06.2025; 11.07.2025 received from your university seeking request for the withdrawal of 150 MBBS seats and 49 seats in MD/MS programmes at Hamdard Institute of Medical Sciences and Research (HIMSR) for the academic year 2025-26 on the grounds of alleged irregularities and unauthorized use of the institution's name by individuals not associated with Jamia Hamdard, and not appointed as Principal/Dean of HIMSR by the competent authority, as per the UGC (Institutions Deemed to be Universities) Regulations. The aforesaid request was subsequently confirmed by your University through a formal communication withdrawing the earlier letters of consent granted to HIMSR for conducting MBBS and MD/MS programmes for the academic year 2025-26.

2. In light of the aforesaid facts and the relevant provisions of UGC (Institutions Deemed to be Universities) Regulations, 2023, the National Medical Commission considered the matter in its Coordination Meeting held on 22.07.2025 wherein the broader interest of the academic and career prospects of the students were considered and the Commission decided that no renewal be granted to HIMSR for 150 MBBS seats for the academic year 2025–26. Please note that this decision

pertains solely to admissions for the academic year 2025-26. The matter may be reconsidered for future academic sessions, subject to the outcome of the pending court cases being filed by the Jamia Hamdard (deemed to be) University or HIMSR or any other connected parties in relation to the ongoing dispute, before Hon'ble High Court of Delhi or before any other court of law.

- 3. Furthermore, it is clarified that this decision will not affect students who are already enrolled at HIMSR. Their admissions remain valid and must be duly regularized by Jamia Hamdard (Deemed to be University).

The Jamia Hamdard administration is receiving several queries through email and other channels regarding clarity about submissions of tuition, examination and other fees as well as conduct of university examinations in respect of medical students (MBBS, MD/MS/M.Sc-Medical/Ph.D courses) enrolled in Jamia Hamdard.

In this regard, it is notified to all enrolled students of HIMSR and their parents that: -

Remittance of Students Fees: A.

- As per the statutory requirements under the UGC (Institutions Deemed to be Universities) Regulations, 2023 which is binding on Jamia Hamdard (being a deemed to be University) all kind of tuition and other fees of every enrolled student of Jamia Hamdard in different schools/departments/centers including Hamdard Institute of Medical Sciences and Research (HIMSR) are to be deposited only in the University operated bank accounts.
- For the medical students of HIMSR, a separate bank account No. 0915040520000004 in favour ii. of Jamia Hamdard, Hamdard Institute of Medical Sciences & Research (HIMSR), IFSC Code: JAKA0JAMIAH, linked with Jamia Hamdard PAN No. AAATJ2432R with the Jammu and Kashmir Bank Branch, Jamia Hamdard Campus, New Delhi-110062 as per the regulatory requirements has been opened and being operational.
- All the existing medical students are, therefore, once again advised to deposit all their fees iii. ONLY with the above official bank account of Jamia Hamdard in their own interest failing which the Jamia Hamdard administration will not be responsible for any lapse on the part of the students in this matter.
- The Bank A/c No. 0127002100093391 in the name of Hamdard Institute of Medical Sciences iv. and Research (HIMSR) with Punjab National Bank (PNB) Branch, Asaf Ali Road, New Delhi (MICR Code 110024038 Swift Code PUNBINBBISB SOL number 012700) is an unauthorised account and opened by a third-party society namely Hamdard Education Society (HES) with its PAN or any other account. Besides, the C&AG Audit team also objected to the same in its report dated 02.05.2025 Therefore, all medical students are advised to be cautious about the same while remitting their fees. Jamia Hamdard will not be responsible for any wrong remittance to such unauthorised bank account.

В. Holding of University Examinations for MBBS/MD/MS/M.Sc/Ph.D course work

All University Examinations of MBBS students viz. First Professional, Second Professional and Third Professional as per the requirements of MBBS byelaws of HIMSR Students and Revised Competency Based Medical Education Curriculum (CBME) Guidelines, 2024 -National Medical Commission circulated vide No.D-11011/500/2024/AC New Delhi, dated the 12th Sept 2024 as well as MD/MS shall be held by Jamia Hamdard (Deemed to be University) only as per the Date Sheet and/or notification issued under the signatures of the Office of the Controller of Examinations and not at the School/HIMSR level

- As per the Examinations Rules and in terms of UGC Institutions Deemed to be Universities Regulations, 2023 no other officer or officials are authorized to hold any University Examinations for the regular students including the medical students of HIMSR. All students and teachers are hereby advised not to take cognizance of such illegal and unauthorized examinations or date sheet or notices other than the office of the Controller of Exams of Jamia Hamdard.
- That the Teacher In charge of the Examination Cell of HIMSR, Jamia Hamdard is hereby directed to take note of the above in the larger academic interest of the students. All such examination related papers of HIMSR shall only be routed through the legally appointed Principal/Dean, HIMSR i.e. Prof. Sudhir Kumar Jain. He is functioning from Room No.107-A of First Floor of the Administrative Block, Science Building, Jamia Hamdard. He is available for any assistance and redressal of student grievance. - With regard to signing of documents etc. by Prof Musharraf Hussain (under suspension) claiming to be the Dean of HIMSR such documents cannot be accepted by Jamia Hamdard in the larger interests of students. Jamia Hamdard cannot in the interests of students accept such illegal and void documents as it will ultimately harm the career of the students.

C. Decision of the National Medical Commission:

- 1. The NMC after taking into cognizance of the large-scale statutory violations in admission, examinations, illegal bank accounts by third parties and unauthorized persons at HIMSR, in the broader interest of the academic and career prospects of the students has decided that no renewal be granted to HIMSR for 150 MBBS seats for the academic year 2025-26.
- The NMC in its recent communication dated 24.07.2025 also clarified to the Jamia Hamdard that this decision will not affect the students who are already enrolled at HIMSR and their admission remain valid and must be duly regularized by the Jamia Hamdard (Deemed to be University). Modalities will be worked out soon by the Jamia Hamdard in consultation with the NMC with the approval of the competent bodies of Jamia Hamdard in compliance with the UGC Regulations.
- 3. It is also to notify to all students concerned that the Jamia Hamdard is a Deemed to be University and is bound to comply with the directions issued by the UGC and NMC and is committed to safeguard the interests of all enrolled medical students in Jamia Hamdard. Jamia Hamdard seeks the cooperation of the students and teachers of HIMSR in this regard.

Seeking clarification regarding consent of affiliation to Hamdard Institute

of Medical Sciences and Research (HIMSR)

Sir,

With reference to your letter No. U-11021/Legal-UGMEB/24878/NMC/2 dated 10.07.2025 on the above subject, I am directed to write to clarify the following facts: -

- Jamia Hamdard is Unitary in nature with no powers to grant affiliation to other Institutions: As stated earlier in our letter of even No. ECOR/89, dated 01.07.2025 in response to your previous communication dated 30.06.2025, Jamia Hamdard being a deemed to be University has no powers to grant affiliation to other institutions being run under a third party. In this regard UGC communication addressed to the Registrar, Jamia Hamdard vide letter F.No.F.2-10/2023(AC-Policy) dated 09.07.2024 may be referred to. In the said communication while rejecting the application for conferment of autonomous status to HIMSR, it was informed by the UGC that a Deemed University, cannot be an affiliating University as per clause 26 of the UGC Institutions Deemed to be Universities Regulations, 2023. Further, the matters regarding grant of affiliation of colleges under a University are governed by UGC (Affiliation of Colleges by Universities) Regulations, 2009 and according to which, they shall apply only to universities established or incorporated by or under a Central Act, a Provincial Act or a State Act. It shall not apply to a deemed to be University which has been created under section 3 of the UGC Act, 1956. (Annexure-1/Colly) Consequently, Hamdard Institute of Medical Science's and Research (HIMSR) cannot be treated as an affiliated institution of Jamia Hamdard and it is a constituent of the Jamia Hamdard.
- ii. HIMSR has no legal status of its own and established by Jamia Hamdard: Hamdard Institute of Medical Sciences and Research is an institution established by the Jamia Hamdard (Deemed to be University) and HIMSR has no legal status of its own. It is not a registered society nor granted any autonomous status by the UGC. As on date it is part and parcel of the Jamia Hamdard for all purposes. Hence there is no question of granting any affiliation to it by Jamia Hamdard for its independent functioning without the interference of the Jamia Hamdard in its day-to-day administration. Hence, the NMC cannot directly deal with the HIMSR bypassing the authority of the Jamia Hamdard (Deemed to be University) Regulations, 2023 which has originally made the application for establishment of the Medical College HIMSR to be run by the Jamia Hamdard in its own campus/institutional land.
- iii. HIMSR is an Institution of Jamia Hamdard and not an affiliated college/institution as per the law. The supporting letter of consent for grant of award of Degree of MBBS to the student of MBBS was issued by the Jamia Hamdard on the strength of the 60th Meeting of

Executive Council Resolution held on 17.03.2010 and 63rd-Meeting of the Executive Council of Meeting held on 05.12.2012 wherein it was resolved to establish a Medical College in the name and style of 'Hamdard Institute of Medical Sciences & Research by Jamia Hamdard (Deemed to be University) in its own campus at Hamdard Nagar, New Delhi. A formal application to MCI was submitted by the Registrar, Jamia Hamdard on 27.09.2010 after obtaining Essentiality Certificate from the Govt. of NCT of Delhi. Accordingly, the Letter of Permission (LoP) was granted by the MCI in favour of the Jamia Hamdard. Jamia Hamdard at no point of time gave any affiliation to HIMSR. (Annexure-2/Colly).

- Resolution of the Executive Council not to offer MBBS/MD/MS Programmes in iv. HIMSR for new academic year 2025-26 because of large scale violations of UGC Regulations, 2023: The Executive Council in its 70th Meeting held on 27.02.2025 because of larger violations of UGC (Institutions Deemed to be Universities) Regulations, 2023 in relation to admission of students, illegal fee collection and diversion of university funds to third party bank accounts, it was resolved to not to include the medical programmes (MBBS/MD/MS) in the University Admission Prospectus for the new academic year 2025-26 to stop further violations by third parties. The EC also resolved that NMC be informed once again about the decision of the University bodies to stop illegal admissions by unauthorised persons using the name of Jamia Hamdard on the MCC portal in the academic year 2025-26. The ADG (Medical Education) and Secretary, NMC was informed about the decisions taken by the Academic Council and Executive Council related to the admission of medical students in HIMSR vide letter F.No. JH/RO/HIMSR.2025/ECOR/55, dated 25.04.2025, followed by a second letter of even No.ECOR/62, dated 09.05.2025 (Annexure-3). But unfortunately, none of these communications were taken cognizance by the NMC or MCC which ultimately resulted into filing of a Civil Writ Petition No. 6511 of 2025 by Jamia Hamdard in which Ministry of Health and Family Welfare, NMC and MCC are parties. Finding no alterative and in order to protect the interest of the Jamia Hamdard and prospective medical students, a formal letter requesting withdrawal of MBBS (150 seats), MD/MS 49 seats in HIMSR for the academic session 2025-26 was sent to the NMC as well as MCC vide letter of even No. ECOR/74 & 75 dated 06.06.2025. In the said letter, the Jamia Hamdard had categorically stated that a stage has been reached where it may not be possible for the Jamia Hamdard to offer the MBBS and MD/MS programmes for the new academic year 2025-26.
 - 2. In the light of the decisions of the Academic Council and Executive Council of the Jamia Hamdard and in order to stop the larger scale violations of UGC (Institutions Deemed to be Universities) Regulations, 2023 by third parties, I am hereby reconfirming the withdrawal of all the previous letters of consent for offering MBBS, MD/MS programmes in HIMSR issued by the Jamia Hamdard (Deemed to be University) for the new academic year 2025-26.

Seeking explanation regarding student grievances arising from institutional dispute between Jamia Hamdard and Hamdard Institute of Medical Sciences and Research (HIMSR) – regarding

Sir.

With reference to your letter dated 30.06.2025 on the above subject, I am directed to submit the response on behalf of the Jamia Hamdard (Deemed to be University) to the queries raised in NMC questionnaire along with supporting documents.

The above replies to the questionnaire may be read with the grievances raised by the Jamia Hamdard against the NMC in the Civil Writ Petition No.6511 of 2025 filed titled 'Jamia Hamdard Vs Union of India, NMC and MCC' pending before the Hon'ble High Court of Delhi. It is once again reiterated that:

- a) Jamia Hamdard is a unitary university with no powers to grant affiliation.
- b) Hamdard Institute of Medical Sciences and Research is an institution established by the Jamia Hamdard (Deemed to be University) and HIMSR has no legal status of its own.
- c) Prof. Sudhir Kumar Jain is the legally appointed principal/Dean of HIMSR, Jamia Hamdard.
- d) Jamia Hamdard did not enter into any agreement with either HNF-MREC or Hamdard Education Society to run the medical college.
- e) As per the UGC Regulations and directives the assets of Jamia Hamdard and HIMSR cannot be transferred to any third-party society without the due approval of Government of India/UGC.
- f) Jamia Hamdard is not a party to either the private family settlement deed or arbitral proceedings before the Ld Arbitrator. Hence, there is no question of institutional disputes between Jamia Hamdard and HIMSR as such mentioned in your communication.

g) NMC cannot directly deal with unauthorised persons who are claiming to be the Dean of HIMSR or CEO of HIMSR or sponsoring body of HIMSR etc. bypassing the Jamia Hamdard statutory authorities and its officers.
