- c) Facilitating the creation of a learner-centric environment conducive to quality education and faculty development to adopt the required knowledge and technology for participatory teaching and learning processes;

- d) Collection and analysis of feedback from all the stakeholders on quality-related institutional processes;
- e) Dissemination of information on various quality parameters to all the stakeholders;
- f) Organization of intra- and inter-institutional workshops and seminars on quality-related themes and promotion of quality circles;
- g) Documentation of various programmes/activities leading to quality improvement;
- h) Acting as a nodal agency of the JH for coordinating quality-related activities, including adoption and dissemination of the best practices;
- i) Development and maintenance of institutional database through MIS for the purpose of maintaining and enhancing institutional quality;
- j) Periodical conduct of Academic and Administrative Audits along with their follow-up activities;
- k) Preparation and submission of the Annual Quality Assurance Report (AQAR) as per the guidelines and parameters of NAAC; and
- l) To submit the AQAR to the Academic Council/BOM/Executive Council from time to time for quality evaluation purposes.

4. Tenure of the IQAC:

The tenure of the members of the IQAC except the ex-officio members shall be for a period of two years from the date of this notification.

5. Meetings of the IQAC:

The IQAC shall meet at least once in a quarter. The quorum for the meeting shall be 2/3rd of the total number of members. The Director, IQAC being the Member Secretary shall be responsible for maintaining proper Minutes electronically in a retrievable form and to be uploaded on the JH website-IQAC webpage from time to time.
