



2. The tenure of the members in respect of point B and C shall be two years. The quorum for the meetings shall be 2 out of 3 members (including Chairman)
3. The SAIP is expected to function in terms of UGC (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Education Institution) Regulation, 2018. It shall also investigate case of plagiarism as per the provisions mentioned in the regulation.
4. The SAIP shall follow the principles of the natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff.

5. The SAIP shall have the power to assess the level of plagiarism and recommend penalty(ies) accordingly.
6. The SIAP after investigation shall submit its report to the Institutional Academic Integrity Panel (IAIP) with its recommendation on penalties to be imposed within a period of 45 days from the date of receipt of complaint/ initiation of the proceedings.
