The rates should be written both in words and figures, free from erasure(s) and over writing(s) and error in typing/writing. Any erasure/error/ correction must be attested by the bidder otherwise bid shall be rejected. The technical bid shall be opened first and shall be referred for technical evaluation. The financial bid of only those bidders whose technical bids are found acceptable by the Technical Evaluation Committee will be considered for opening. The award of contract shall be considered to the lowest bidders fulfilling the conditions. The Jamia Hamdard reserves the right to reject lowest tender or all the tenders or accept any tender or part thereof without assigning any reason.

General Terms and Conditions for Tendering Microsoft Licenses (2024)

1. Authorization & Licensing

- The vendor must be a Microsoft Certified Partner, preferably a Microsoft Partner/Solutions Partner.
- The vendor must provide **authorized and genuine Microsoft Office licenses**, with validation support
- The licenses should be Perpetual.
- A certificate of authenticity or equivalent proof of genuine licensing must be provided.
- Must possess valid Authorization letter from Microsoft Corporation issued in the name
 of Jamia Hamdard, and licenses should also be accessible in Microsoft Portal for Keys and
 downloads.
- Must have experience in supplying Microsoft licenses to Government, Educational Institutions or PSUs and Corporates for a minimum period of 3 years.
- Must be registered under applicable tax laws (e.g., GST, PAN, etc. in India).

2. Delivery and Installation

Delivery must be made within the stipulated time frame (e.g., 2–4 weeks) from the date of Issue of Purchase Order (PO).

- Installation assistance must be provided, if applicable.
- A certificate of successful delivery and installation may be required.

3. Pricing and Payment

- Prices should be quoted in (INR) and must be inclusive of all applicable taxes.
- No escalation of prices is allowed after submission.
- Payment terms: usually 30–60 days after successful delivery and acceptance.

4. Validity of Bid

• The bid must remain valid for a specified period, typically 90 to 180 days from the date of tender opening.

5. License Compliance

- All licenses must be verifiable via Microsoft Volume Licensing Service Center (VLSC).
- The vendor is responsible for ensuring license authenticity and compliance.

6. Termination

• The institution reserves the right to terminate the contract in case of non-performance, delay, or supply of unauthentic licenses.

7. <u>Dispute Resolution</u>

- Any disputes shall be subject to jurisdiction of the local courts where the institute is located.
- Preferably resolved through arbitration, as per institutional procurement policy.

8. Confidentiality

• The bidder must not disclose any institutional data or software license keys to unauthorized personnel outside or inside Jamia Hamdard.

9. Force Majeure

Standard clause covering natural disasters, war, strikes, etc., exempting parties from liability under such events

10. Other Term & Conditions of Tender

- MSMEs/NSIC registered suppliers (certificate to be submitted for exemption) is exempted
- from EMD fee.
- Jamia Hamdard will deduct an amount of 0.25% from all the bills for "Jamia Hamdard Relief and Welfare Fund".
- Any notification for changes in specifications/terms shall be through corrigendum/ addendum which shall only be notified on www.jamiahamdard.ac.in
- In the event of a bidder backing out before actual award or execution of agreement, JH will have right to forfeit the EMD.
- In case the successful tenderer (L-1) Declines the offer of contract, for whatsoever reason(s) his EMD will be forfeited.
- The agency shall not assign, sub-contract or sub-let the whole or any part of the contract if any manner except with the specific approval of Jamia Hamdard.
- In the case of the lowest is more than one, then it would be at the discretion of JH to decide the L1.

2. Experience & References

• The vendor must provide client references or purchase orders as proof for supply of Microsoft License(s).

3. Technical Support & SLAs

- The vendor should provide installation support, activation assistance, and post-sale technical support.
- The vendor must specify response and resolution times (SLAs) for support queries.
- Optional: Availability of remote or onsite support depending on the organization's requirements.

4. Bid Submission & Validity

- Bids must be submitted in the prescribed format with all supporting documents.
- Bids should remain valid for a minimum of 90 days from the date of submission
