## **NOTIFICATION**

Sub.: Last Opportunity to Exercise Option for NPS (Corporate Sector of PFRDA)- Reg.

In accordance to the resolution of the 69<sup>th</sup> meeting of the Executive Council as held on 07-08-2024, notified vide Notification No. JH/RO/EC-69/2024/ICOR/85 dated 30.08.2024, all regular employees of Jamia Hamdard were informed about the adoption of NPS (Corporate Sector) of PFRDA and were given an opportunity to switch over from the Contributory Provident Fund (CPF) to NPS (Corporate Sector) by exercising their option in writing, through a prescribed Option Form, within a period of one month from the date of notification i.e. upto 30-09-2024.

- 2. Further, as per resolution of 70<sup>th</sup> Meeting of the Executive Council as held on 27-02-2025, vide notification no. Estab./LD/2025/325 dated 13-03-2025; it was notified that the Employer's Contribution under NPS (Corporate Sector) for Jamia Hamdard employees who have opted for NPS shall be enhanced from the existing 10% to 14%, effective from September 2024 onwards.
- 3. After the subscription deadline on 30-09-2024, a number of teaching and non-teaching employees have approached the University administration with requests to exercise their option to switch from CPF to NPS (Corporate Sector).
- 4. Further, the Finance Investment committee in its meeting held on 27-03-2025 recommended to re-issue notification for seeking option from interested employees on regular pay scale to switch over from CPF to NPS (Corporate Sector).
- 5. In view of the above, the Competent Authority has been pleased to provide one final opportunity to all interested employees on regular pay scale to exercise their option to switch from CPF to NPS (Corporate Sector) by submitting their option in the prescribed Option Form to the Establishment Section on or before 15-07-2025.
- 6. No further request for switching from CPF to NPS (Corporate Sector) shall be entertained thereafter.
- 7. All concerned employees are requested to take note of the above and act accordingly. The matter shall be reported in the upcoming meeting of the Finance Committee and Executive Council.
