PUBLIC NOTICE

Sub: Appointment of Prof. Sudhir Kumar Jain as Principal/Dean, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard, New Delhi

It is notified to all concerned that **Prof. Sudhir Kumar Jain** has been discharging the function as the Principal/Dean, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard (Deemed to be University) w.e.f. 11.11.2024 vide Notification F.No. JH/RO/Estab/HIMSR/2024/ICOR/95, dated 11th November, 2024. HIMSR is a medical college established by the Jamia Hamdard and all the approvals for running the MBBS/MD/MS programmes and essentiality certificates are in the name of Jamia Hamdard (Deemed to be University). The degrees of all students passed out from HIMSR were administered by Prof. Sudhir Kumar Jain in the University Convocation held on 16.04.2026.

2. The position of the Dean of a School/Faculty/Institution of a deemed university is one of the statutory officers and governed under Regulation 23. I of the UGC (Institution Deemed to be Universities) Regulations, 2023. Further every teaching staff of a deemed to be university shall be appointed by the Executive Council of the Jamia Hamdard in terms of the UGC Regulations governing deemed to be Universities. Further Regulation 3 of the NMC "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022" as notified vide Gazette notification dated 14th Feb 2022 regarding General Norms for Appointment of Faculty in Medical Institutions mandates that every appointing authority before making an appointment to a teaching post in a medical college or institution shall observe prescribed norms.

3. However, it has been noticed that Prof. Musharraf Husain, Department of Surgery, HIMSR, an institution of the Jamia Hamdard has been falsely claiming to be the Principal/Dean without any authority or approval by the Competent authority of Jamia Hamdard. The said Prof. Musharraf Husain has been placed under suspension by the Jamia Hamdard from 6th Feb 2024 on the grounds of gross misconduct and financial impropriety. Prof. Musharraf Husain falsely representing himself as National Medical Commission recognized Dean, HIMSR. In the similar circumstances, a warning letter has been issued by the NMC to another suspended Professor namely Dr. Sunil Kumar Kohli vide Director, MARB, National Medical Commission wherein he was asked to refrain from using the term that he has been authorised by NMC to be the Principal of HIMSR till final directions from the Hon'ble High Court are pronounced.

4. The Jamia Hamdard will not be responsible for his act, commission, omission or agreement if any executed by him on behalf of HIMSR/HAHCH in any capacity. No correspondence shall be made by any officers of the Jamia Hamdard with the said Prof. Musharraf Husain referring him as Principal/Dean of HIMSR.
