## **PUBLIC NOTICE**

Sub: Appointment of Prof. Sudhir Kumar Jain as Principal/Dean, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard, New Delhi

Prof. Sudhir Kumar Jain has been discharging the function as the Principal/Dean, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard (Deemed to be University) w.e.f. 11.11.2024 vide Notification F.No. JH/RO/Estab/HIMSR/2024/ICOR/95, dated 11th November, 2024. HIMSR is a medical college established by the Jamia Hamdard and all the approvals for running the MBBS/MD/MS programmes and essentiality certificates are in the name of Jamia Hamdard (Deemed to be University).

- 2. It has been noticed that one disgruntled faculty member namely Prof. Sunil Kohli (under suspension since 06.02.2024 for misconduct), Department of Medicine, HIMSR, Jamia Hamdard has been acting against the interest of the Medical College viz. HIMSR, Jamia Hamdard by falsely representing himself as National Medical Commission approved Dean, HIMSR and appointed by a third party not connected to the affairs of the University or medical college since July 2024. Neither the UGC Regulations nor the byelaws of Jamia Hamdard approved by the UGC or Ministry of Education, National Medical Commission permits for such appointments.
- 3. The said Prof. Sunil Kohli also illegally acted as authorized signatory along with two of his accomplices to operate illegal bank accounts opened in the name of HIMSR/HAHCH and/or Hamdard Education Society (HES) (Regn No. 11517 of 1981) to collect students' fees of medical students and helped the office bearers of the said society including one Dr. Ghulam Nabi Qazi, claiming himself as CEO of HIMSR to siphon off a large sum of university funds through illegal means. All such illegal bank accounts opened in four banks were marked as 'debit freeze' on the request made by the Jamia Hamdard on the grounds of non-compliance of RBI guidelines and KYC norms.
- 4. Two private persons, the main beneficiary of these illegal accounts and Prof. Sunil Kohli had approached the Delhi High Court through various petitions and Applications against the RBI, Banks, Jamia Hamdard in the past. But no relief has been granted by the Hon'ble High Court in their favour. The said professor Sunil Kohli under suspension had also challenged the appointment of Prof. Sudhir Kumar Jain as Principal/Dean in CWP No. 17684 of 2024 titled 'Abdul Majeed & others Vs Jamia Hamdard & National Medical Commission. However, no relief whatsoever has been granted to the petitioners in this case by the Hon'ble High Court till date. Consequently, Prof. Sudhir Kumar Jain continues to function as Principal/Dean, HIMSR, Jamia Hamdard.
- 5. The said Prof. Sunil Kohli is also making a false claim that Jamia Hamdard had transferred its Medical College viz. HIMSR and HAHCH to a third-party society namely Hamdard Education Society and the same is impermissible under the law and UGC Regulations as applicable to deemed to be Universities. It is also denied that the Jamia Hamdard had entered into any type of agreement or arrangement to run MBBS/MD/MS courses under HIMSR under a third-party management.
- 6. Due to non-cooperative attitude, non-compliance of orders by the In-charge, Examination Cell, HIMSR and because of undue interference by the said suspended professor Sunil Kohli, the

University Administration had to postpone the 3<sup>rd</sup> Prof. (Part 1<sup>st</sup>) Theory Examinations of MBBS (2021 Batch) commencing from today i.e. 21.01.2025 in the larger interest of the students. The office of the Controller of Examinations, Jamia Hamdard has been strictly instructed not to recognize any examinations conducted on the instance of unauthorized person of HIMSR or private parties. The Jamia Hamdard administration is fully committed to protect the academic careers of the students enrolled in MBBS/MD/MS to the extent possible under the law and as per UGC Regulations. It is also clarified that the 3<sup>rd</sup> Prof. (Part 1<sup>st</sup>) Theory Examinations of MBBS (2021 Batch) commencing from today i.e. 21.01.2025 are being conducted unilaterally by the said suspended professor Sunil Kohli despite explicit instructions of the University to the contrary and the University does not recognise the conduct of any such examinations and such examinations are null and void.

- 7. Through this Notice, all students, faculty, staff of HIMSR/HAHCH, Jamia Hamdard are hereby informed that any body dealing with the said Prof. Sunil Kohli and his two accomplices under suspension namely Prof. Musharraf Husain, HIMSR/HAHCH, Dr. M.S. Kidwai, HAHCH and Dr. Ghulam Nabi Qazi shall be doing so at their own risk and responsibility. Police Complaints against the above-named persons have been lodged for forgery, breach of trust, siphoning off medical students' fees by fraudulent means and duping innocent medical students and their parents with misleading information in the illegally published brochure. Recently one FIR has also been lodged with Delhi Police against the office bearers of the said third party society for obtaining GST by using forged document.
- 8. The Jamia Hamdard will not be responsible for their act, commission, omission or agreement made by them on behalf of HIMSR/HAHCH in any capacity and claims under any circumstances. No correspondence shall be made by any officers of the Jamia Hamdard with them in their official capacity connected to the matters of HIMSR/HAHCH.
- 9. This Notice is issued in the larger interest of the students, their parents, faculty and staff members of Hamdard Institute of Medical Sciences & Research (HIMSR) and Hakeem Abdul Hameed Centenary Hospital of Jamia Hamdard.

This issues with the approval of the Vice-Chancellor.
